Applications are invited online only through One Time Registration from qualified candidates belonging to Ezhava/Thiyya/Billava, Scheduled Caste, Muslim, Latin Catholic/Anglo Indian and Dheevera Communities of Kerala State for selection to the following post.

- 5 Method of Appointment : Direct Recruitment from Ex-servicemen only.
(Candidates belonging to Ezhava/ Thiyya / Billava, Scheduled Caste, Muslim, Latin Catholic/Anglo Indian and Dheevera Communities)
Note :- The applications submitted by candidates belonging to the communities other than Ezhava/ Thiyya/Billava, Scheduled Caste, Muslim, Latin Catholic/Anglo Indian and Dheevera Communities will be summarily rejected. No rejection memo will be issued to them individually.
- 6 Age Limit : **Scheduled Caste - 18-50.** Only candidates born between 02.01.1969 and 01.01.2001 (both dates included) are eligible to apply for this post.
Ezhava/Thiyya/Billava, Muslim, LC/AI, Dheevera – 18-49 .Only candidates born between 02.01.1970 and 01.01.2001 (both dates included) are eligible to apply for this post.
Note :- The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of Five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of

their provisional service in the concern and shall produce the same as and when required by the Commission. It would also be clearly specified in the certificate that they were not working in the regular service of the concern.

7. Qualifications :

- (1) SSLC Failed (Applications from those who have passed SSLC shall not be considered)
- (2) Not less than 3 years service in the Armed Force i.e Army/Navy/Air Force.
- (3) Cycling
1. (4) Must possess valid license in driving Motor Vehicles.

- Note:-
- (i) The number of candidates to be included in the short list/probability list of the above post will be decided as per the availability of admitted applications.
 - (ii) The above vacancies are existing at present. The Ranked List published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked to the above communities (Ezhava/Thiyya/Billava, Scheduled Caste, Muslim, Latin Catholic/Anglo Indian and Dheevera Communities) but remain unfilled due to the paucity of candidates during the currency of the Ranked List published on 09.05.2016 for the post (Cat.No.469/2010). This is the IIIrd NCA Notification published due to non-availability of Ezhava/Thiyya/Billava, SC, Muslim, LC/AI, Dheevera candidates in the Ist NCA Notification (Gazette Dated 28.02.2017 Category Nos 14/2017 to 18/2017), IInd NCA Notification (Gazette dated 26.07.2018 Category Nox 104/2018 to 108/2018).
 - (iii) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.
 - (iv) Differently abled candidates and women are not eligible to apply for this post.

8 Mode of submitting applications:

- (a) Candidates shall register as per 'ONE TIME REGISTRATION ' system on the

Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' for applying for the post. Candidates who have registered shall apply by logging on to their profile using their User-ID and password. Candidates shall click on the 'Apply Now' button of the respective posts in the Notification Link for applying for a post. No application fee is required. Candidates can view and have a print-out of the details in the profile by clicking the link Registration Card, if required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before applying for a post, candidates must ensure correctness of the information in their profile. They must quote the User-Id for further communication with the Commission. Applications once submitted will be received as provisional and particulars shall not be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove qualification, community, age etc have to be produced as and when called for.

(b) "If written/OMR/Online Test is conducted as part of this selection candidates shall submit a confirmation for writing the examination through their One Time Registration profiles. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The application of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. Then periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it."

(c) **"Candidates who have Aadhaar Card should add Aadhaar Card as ID proof in their profile".**
