The Ranked List thus prepared and published by the commission shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to the paucity of candidates during the currency of the Ranked List published for the post in the following dates in the following district or for three years from the date of finalising the NCA ranked list as per this notification whichever is earlier.

- (ii) Candidates belonging to the above reservation communities shall submit application for this post to anyone of the above Districts where the Vacancy is existing for their communities and shall note the name of that district against the relevant column in the online application. Applications should not be submitted to more than one district in response to this notification. If applications are submitted contrary to the above direction and if he/she is selected his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her.
- (iii) In the case of change in Caste/Community noted in the SSLC Book, candidates must claim their original Caste/Community in the application and shall produce Community Certificate/ Non-Creamy Layer Certificate issued by the Revenue Authorities and the Original Gazette notification publishing the change of Caste/Community at the time of OTR verification for the selection to the above post.
- (iv) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O.(MS) No. 154/71/PD dated 27/5/1971. A candidate advised for appointment in one Revenue District from the ranked list prepared is not eligible for transfer to another district unless he/she completes five years continuous service in the former district. Even if transfer is allowed after five years, it will be

subject to the rule in G.O (MS)No.4/61/PD dated 02.01.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post.

5. **Method of appointment** **of:** Direct Recruitment (From candidates belonging to Muslim, SIUC Nadar, LC/AI, Hindu Nadar, Dheevara, Viswakarma & OBC Communities of Kerala State Only)

Note:-Application submitted by candidates other than those belonging to above mentioned Communities will be summarily rejected. No rejection memo will be issued to those candidates.

- 6 **Age Limit** 18-44. Only candidates born between 02.01.1975 and 01.01.2001 (both dates included) are eligible to apply for this post.(Including the relaxation as per para 2(i)of General Conditions)

Note:- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 (fifty) years, please see para (2) of the General conditions under part II of this Notification.(except para 2 (i))

- 7.**Qualifications:** 1) General:- SSLC
2)Technical:- Auxiliary Nurse Midwifery Certificate (Revised Course of 18 months duration) issued by the Kerala Nurses and Midwives Council.

OR

Auxiliary Nurse Midwifery Certificate/Auxiliary Nurse Midwifery Certificate (Revised Course) issued by an authority recognized by the Indian Nursing Council.

OR

Health Workers Training Certificate issued by the Kerala Nurses and Midwives Council.

3)Registration with the Kerala Nurses and Midwives Council.

Note:-1 In the case of candidates belonging to other backward classes the General qualification will be relaxed as completed SSLC course subject to the conditions that this relaxation will be allowed only to the extent necessary to fill up the quota reserved for OBC in the absence of qualified candidates in the other backward classes.

2 Differently Abled candidates are not eligible to apply for this post Concessions for Differently Abled Candidates contemplated in para 2&5 of the General Conditions are not applicable for selection to this post.

3 Rule 10 a(ii) of KS&SSR Part II is applicable for selection to this post Candidates claiming equivalent qualification should produce relevant Government orders during OTR Verification to prove that

the qualification claimed is equivalent to the prescribed qualification for this post .

8 Mode of submitting Applications:-

Candidates must register as per 'ONE TIME REGISTRATION 'scheme through the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have already registered can apply by logging in to their profile using their User ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification link to apply for a post. The photograph uploaded should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking of the photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates can view the details in their profile by clicking the link 'Registration Card' in their profile. A print out of the same can be taken if needed. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for. "Candidates who have Aadhaar Card should link their Aadharcard as ID proof in their profile"

10 If written/OMR/Online Test is conducted as part of this selection, candidate shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the admission tickets in the last 15 days till the date of test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. Appropriate disciplinary action, As per Rule 22 of the KPSC Rules of Procedure will be taken against those candidates who submit application for the post with false claims of Possession of prescribed qualification, experience etc, and give confirmation for examination, irrespective of whether they have appeared or not for the examination. The periods regarding the submission of confirmation and the availability of admission tickets will be published in the Examination calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it. Candidates who have downloaded the Admission Tickets will alone be permitted to attend the Examination.
