Applications shall be submitted online only through the official website of the Commission only after "ONE TIME REGISTRATION". Candidates who have already registered can apply through their profile. The photo uploaded through One Time Registration should be taken after 31.12.2010 and also bear the name of candidate and the date of photo taken at the bottom of the photograph. The uploaded photo will be having a validity of ten years from the date of photograph taken.

Candidates who have AADHAAR should add the same as ID Proof in their profile.

Note:

1. The above vacancies are now in existence. The list of selected candidates published by the Commission in pursuance of this Notification shall remain in force for a minimum period of One year and a maximum period of three years provided that the said list will not continue to be in force if a new Ranked List after the minimum period of expiry of one year is published. Candidates will be advised against the vacancies shown above and for all the vacancies reported during the period of currency of the Ranked list.

2. The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of the candidates, provided that the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

3. 3% of the vacancies for the post shall be reserved for differently abled candidates with Low vision, Hearing

- 5 Method of appointment : Direct Recruitment
- 6 Age : 18-36, Only candidates born between 02.01.1984 and 01.01.2002 (both dates included) are eligible to apply for this post. Candidates belonging to Other Backward Communities and SC/ST candidates and widows are eligible for usual age relaxation.

Note: The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It would also be clearly specified in the Certificate that they were not working in the regular service of the concern.

- 7 **Qualifications** : 1. Pass in S.S.L.C or equivalent qualification.
2. Any one of the following qualifications acquired after a pass in S.S.L.C
a) SMT Overseer's course (2yrs course)
b) Draftsman course, College of Engineering Guindy
c) Group Certificate under KGTE/MGTE which include all the 4 groups viz Building, Drawing, Building construction, Survey & Irrigation.

Alternatively a pass in the following 8 subjects, will be accepted as a sufficient qualification.

1. Survey & Levelling (Higher)
2. Applied Mechanics (Higher)
3. Building Materials & Construction (Higher)
4. Hydraulics & Irrigation (Higher)
5. Building, Drawing and Estimating (Higher)
6. Earth Work & Road Making (Higher)

- 7. Geometrical Drawing (Lower) or Practical Plane & Solid Geometry (Lower)
- 8. Mensuration (Lower)
- d) Kerala Government Certificate Examination in Civil Engineering
- e) Successful completion of the Certificate course of college of Engineering, Trivandrum.
- f) National Trade Certificate in Draftsman (Civil)
- g) A pass in the Overseer's course conducted by the Government of Kerala.
- h) Diploma in Civil Engineering (2yrs course) of the Women's Polytechnics of the state.

Note:-1) Rule 10 (a) ii of Part II KS &SSR is applicable

2) Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

3) In the case of difference in original caste/community claimed in the applications and that entered in SSLC book, the candidate shall produce a Gazzatte notification in this regard along with Non creamy Layer certificate/caste certificate at the time of certificate Verification.

8 **Mode of submitting applications**

Before applying for the post, candidates should register as per “ONE TIME REGISTRATION” scheme through the Official Website of Kerala Public Service Commission www.keralapsc.gov.in Those who have already registered can apply by logging in to their profile using his/her User ID and password. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates can view, rectify defects and print the details in the registration card by clicking the link **Registration Card** after entering the home page. Candidates are responsible to ensure correctness of the personal information and secrecy of password and they shall keep in mind the user ID for further communication with the Commission. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected. Documents to prove Qualification, age, community etc have to be produced as and when called for.

- 9 Last date of receipt of applications : **09.09.2020** Wednesday upto 12.00 Midnight.
- 10 (a) Sub Paras (v), (viii), (ix), (x), (xi), and (xiii) of para 2 and para 5, 7 of the General Conditions are not applicable to this post.
 (b) The selection to the above concern will be subject to the rules and regulations made by them from time to time.
 (c) If a written/OMR/Online Test is conducted as part of this selection , candidates shall submit a confirmation for writing the examination through

their One Time Registration Profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it.

As per Rule 22 of the Rules of Procedure, appropriate disciplinary action will be taken against those candidates who submit application for the post with false claims of possession of prescribed qualification, experience etc. and give confirmation for examination, irrespective of the fact that they have appeared or not for the examination.
