Applications are invited from qualified candidates for selection to the following post. Applications shall be submitted online only through the official website of the Commission only after "ONE TIME REGISTRATION". Candidates who have already registered can apply through their profile. The photo uploaded through One Time Registration should be taken after 31.12.2010 and also bear the name of candidate and the date of photo taken at the bottom of the photograph. The uploaded photo will be having a validity of ten years from the date of photograph taken.

- 1 **Name of the firm** : Handicrafts Development Corporation of Kerala Ltd.
- 2 **Name of Post** : Sales Assistant
- 3 **Scale of Pay** : ₹ 4,500-7,000  
Selected candidates will be appointed purely on provisional basis for a period of one year terminable without notice at any time during which period they will be paid the scale of pay ₹ 4,500-7,000 or its revision as applicable from time to time.
- 4 **No.of Vacancies** : 05(Five)

Note:

- i) 50% of vacancies shall be reserved for female candidates.
- (ii) The above vacancies are now in existence. The list of selected candidates published by the Commission in pursuance of this Notification shall remain in force for a minimum period of One year and a maximum period of three years provided that the said list will not continue to be in force if a new Ranked List after the minimum period of expiry of one year is published. Candidates will be advised against the vacancies shown above and for all the vacancies reported during the period of currency of the Ranked list.
- (iii) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post,

if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of the candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

iv) 3% of the vacancies are reserved for qualified Differently abled candidates (Blindness/Low vision,Hearing impairment,Locomotor disability/cerebral palsy) as per Lr.No.HDCK/P&A/GW/2010-11/1911 dated 23.09.2010

- 5 Method of Appointment : Direct Recruitment
- 6 Age : 18-36 Only candidates born between 02.01.1984 and 01.01.2002 (both dates included) are eligible to apply for this post. Candidates belonging to Other Backward Communities and SC/ST candidates and widows are eligible for usual age relaxation.

**Note:-** The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of Five years from the upper age limit provided they were within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It would also be clearly specified in the certificate that they were not working in the regular service of the concern.

#### **7. Qualifications:**

- 1) Degree of a recognised University.
- 2) Ability to speak and write English,Hindi and Malayalam.

**Note:**

1. Rule 10 a (ii) of Part II of KS&SSR is applicable.
2. Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

3. If the caste of candidates is wrongly mentioned in their SSLC, they should claim their original caste in their applications and should produce NCLC/ community certificate issued from revenue authority concerned and the Gazette Notification for the same at the time of certificate verification.

## **8 Mode of submitting applications:**

Candidates shall register as per 'ONE TIME REGISTRATION ' system on the Official Website of Kerala Public Service Commission, Viz., [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered shall apply by logging in to their profile using their User- ID and password. Candidates shall click on the 'Apply Now' button of the respective posts in the Notification link for applying for a post. No application fee is required. Candidates can view and have a print-out of the details in the profile by clicking the link 'Registration Card', if required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before applying for a post, candidates must ensure correctness of the information in their profile. They must quote the User- ID for further communication with the Commission. Applications once submitted will be received as provisional and particulars shall not be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove qualification, community, age etc. have to be produced as and when called for .

- 10 (a) Sub Paras v, viii, ix,x, xi and xiii in para 2 and paras 5,6 and 7 of the General Conditions are not applicable to this post.  
(b) The selection to the above concern will be subject to the rules and regulations made by them from time to time.
- 11 If a Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.

**As per Rule 22 of the Rules of Procedure, appropriate disciplinary action will be taken against those candidates who submit application for the post with false claims of possession of prescribed qualification, experience etc. and give confirmation for examination , irrespective of the fact that they have appeared or not for the examination.**
