I NCA NOTIFICATION

Applications are invited Online only by **ONE TIME REGISTRATION** from qualified candidates of SCCC (Scheduled Caste converted to Christianity) community of Kerala State against NCA vacancies for selection to the undermentioned post in Kerala Government Service.

1. **Department** : **Animal Husbandry**
2. **Name of Post** : **Veterinary Surgeon Gr II**
3. **Scale of Pay** : **Rs.39500-83000/-**
4. **No. of vacancies** : **01 (One) -SCCC (Scheduled Caste Converted to Christianity)**

The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked for SCCC (Scheduled Caste Converted to Christianity) as unfilled due to the paucity of candidates during the currency of Ranked List published on 14.12.2017 (Cat.No279/16 Gazette date. 29.09.2016 ) for the post.

5. **Method of appointment** : Direct Recruitment [From among candidates belonging to SCCC (Scheduled Caste Converted to Christianity) community only.]

**NOTE:-**

1. Applications submitted by candidates belonging to communities other than SCCC (Scheduled Caste Converted to Christianity) community will be summarily rejected. Individual rejection memo will not be issued to them.
  2. As per GO (P) No. 61/2012/SWD Dated 17/10/12 Differently Abled candidates with only Locomotor Disability / Cerebral Palsy are identified as suitable for appointment to the post of Veterinary Surgeon in Animal Husbandry department. Hence Differently Abled candidates with blindness /low Vision and Hearing Impairment are not eligible to apply for this post.
6. **Age limit** : 18 – 42: only candidates born between 02.01.1978 and 01.01.2002 (both dates included) are eligible to apply for the post (Including the age relaxation as per para 2(i) of the General Conditions).  
**Note:** For other conditions regarding age relaxation please see Para 2 of General Conditions except para 2(i)

**Note:-**

In the case of those members belonging to Scheduled Castes who had converted to Christianity after adult age and their children are eligible for age relaxation up to 44 years. Such candidates should be born between 02.01.1976 and 01.01.2002 (both dates included. )

## **7. Qualifications:-**

1. Degree in Veterinary Science.
2. Registration with the Kerala State Veterinary Council as envisaged in the Indian Veterinary Council Act., 1984 ( Central Act of 52 of 1984)
3. Working knowledge in Malayalam.

**Note I:-** *Relaxation from the above qualification under item 3 shall be allowed to persons belonging to Linguistic Minorities in the state subject to the condition that they shall pass the Language test in Malayalam as provided in Clause (aaaa) of Rule 10 of Part II of the Kerala State and Subordinate Service Rules, 1958.*

**II:-** *Working knowledge in Malayalam will be assessed by the Commission during the course of selection.*

**III :-** *Rule 10a(ii) Part II of KS & SSR is applicable.*

**IV :-** *Candidates who claim equivalent qualifications instead of qualification in the Notification shall produce the relevant government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.*

**V:-** *In the case of difference in original Caste/Community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette Notification in this regard, along with Non Creamy Layer Certificate/Community Certificate at the time of Certificate Verification.*

**VI:-** *Appropriate disciplinary action as per Rules of Procedure Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.*

## **TRAINING:-**

1. Candidates on appointment as Veterinary Surgeon Gr II shall undergo within the period of probation, the training course conducted by the Animal Husbandry Department and the period of such training shall be treated as duty for the purpose of probation.
2. Persons in the Animal Husbandry Subordinate Service who have worked as Livestock assistants for a period of not less than 5 years and personnel released from the army who are appointed in reserved vacancies will be exempted from undergoing the training.
3. Persons who have undergone the B.VSc and Animal Husbandry course with an inbuilt programme of internship training conducted by the Kerala Agriculture University or any other Agricultural University shall be exempted from undergoing the training.

## **8) Mode of submitting Application:-**

**a)** Candidates must register as per “ONE TIME REGISTRATION” system on the official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)' before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for the post. The Photograph uploaded in the profile should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10

years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link **Registration Card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application, candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is received as provisional and the details cannot be deleted or altered after submission. The applications submitted not in accordance with the conditions stipulated in the notification will be summarily rejected in due course of processing. Documents to prove qualification, Experience, Community, age etc. have to be produced as and when called for.

**b)** If written/OMR/Online Test is conducted as part of this selection candidates shall submit a conformation for writing the examination through their One Time Registration Profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit conformation within the stipulated period, will be rejected absolutely. The periods regarding the submission of conformation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone numbers registered in it.

**C)** Candidates who have AADHAAR card should add AADHAAR card as I.D Proof in their profile.
