Applications are invited Online only from qualified candidates for appointment in the undermentioned post in Kerala Government Service. Before applying for the post the candidates should register as per the One time Registration Scheme through the official website of Kerala Public Service Commission.

- 1 Department** : Insurance Medical Services
- 2 Name of Post** : Assistant Insurance Medical Officer
- 3 Scale of pay** : ₹45,800 - 89,000
- 4 Number of vacancies** : Not Estimated

The list of selected candidates published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancies if any reported to the Commission in writing during the currency of the list.

Note :-As per G.O (P) No. 61/2012/SWD dated 17.10.2012 , Three percentage (3%) of the vacancies for the post will be reserved for eligible differently abled candidates with Locomotor Disability/Cerebral palsy, Blindness and Low vision. Differently abled candidates with Hearing impairment is not eligible to apply for this post as per the above G.O.

- 5 Method of appointment** : Direct Recruitment.
- 6 Age Limit** : 21-42.
Only candidates born between 02.01.1978 and 01.01.1999 (both dates included) are eligible to apply for this post with usual relaxation to scheduled castes, scheduled Tribes and other Backward communities (For other Conditions regarding the age relaxation please see para 2 of the General Conditions)

7. Qualifications

- (1) Degree in Modern Medicine or equivalent qualification.
[Equivalent qualification means those qualification recognised as equivalent by the Medical Council of India.]
- (2) Valid Registration with the Travancore-Cochin Medical Council.

Note :- 1. Rule 10(a)(ii) of Part II KS&SSR is applicable.

2. Those who are appointed in the post should serve for four (4) years during first 10 years of their service (Including the period of training) any where in India or any foreign country under defence Service or Services connected with defence. Those who have completed 45 years of age will be exempted from the above compulsory medical Service.
- 3 Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
- 4 In the case of difference in original Caste/Community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy layer Certificate / Community Certificate at the time of certificate verification.

8. Mode of Submitting applications:

(a) Candidates must register as per “ONE TIME REGISTRATION” with the Official website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the '**Apply now**' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2010. Name of the candidate and the date of photograph taken should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link **Registration Card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application, candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The applications will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove qualification, community, age etc have to be produced as and when called for.

(b) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission

Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.

(c) Appropriate disciplinary action as per Rules of Procedure Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.

(d) Candidates who have AADHAAR card should add AADHAAR card as ID proof in their profile.
