Note 1. The above vacancies are now in existence. The list of selected candidates published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancies noted above and also against the vacancies if any reported to the Commission in writing during the period of currency of the list.

2. Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advice was made under some mistake. On such cancellation, the Appointing Authority shall terminate the service of the candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the Appointing Authority shall be made within the period of his/her probation or 240 days from the date of his /her joining duty whichever is earlier.

The candidates selected to the post shall from the date of appointment be on probation for a period of two years within a continuous period of three years.

9 Mode of submitting applications

Candidates shall register as per 'ONE TIME REGISTRATION' on the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by logging in to their profile using their User- ID and password. Candidates shall click on the 'Apply Now' button of the respective posts in the notification link to apply for a post. No application fee is required. Candidates can view and print the details in the profile by clicking the link Registration Card, if required. They must quote the User-ID for further communication with the Commission. Applications submitted will be provisional and particulars cannot be deleted or altered after submission.
