Applications are invited online only by **One Time Registration** system exclusively from qualified candidates for selection to the under mentioned post in Kerala Government Service. Applications must be submitted online through the official website of the Kerala Public Service Commission after One Time Registration. Candidates who have already registered shall apply through their profile.

1. **Department** : National Cadet Corps (NCC)
2. **Name of Post** : Farrier (Ex-Servicemen Only)
3. **Scale of pay** : ₹. 16500-35700/-
4. **No. of vacancies** : **District wise**
Thrissur - 01 (One)

Notes :

- (i) A Rank list will be prepared for Thrissur District in pursuance of this notification. The ranked list prepared and published by the commission in pursuance of this notification shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancies and also against the vacancies, if any, reported during the currency of the list. In case no candidates is advised from the ranked list till the expiry of the period of three years, the duration of the Ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.
- (ii) The selection in pursuance of the notification will be made on a revenue district basis subject to the special conditions laid down in GO (MS) No.154/71/PD dated 27/05/1971. A candidate advised for appointment from the Ranked List prepared in one revenue district is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O. (P) No. 36/91/P&ARD, dated 02.12.1991 for inter district transfers. Candidates already in Government service holding this post in any district are prohibited from applying in response to this notification.

- (iii) If the community claim in the application differs from the community noted in SSLC, then such changes are to be published in the gazette on or before the date of verification of original documents and the same should be produced along with the Community Certificate/Non Creamy Layer certificate issued by the Revenue authorities at the time of One Time Verification.

5. Method of appointment : Direct Recruitment (Ex-servicemen only)

6. Age : 18-36, Only candidates born between 02.01.1984 and 01.01.2002 (both dates included) are eligible to apply for the post with usual relaxation to Scheduled Caste/ Scheduled Tribe and Other Backward communities. (Including the relaxation as per Para 2(i) of the General Conditions)
[For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 (fifty) years (including all concessions). Please see Para (2) of the General Condition under Part II of this notification]

7. Qualifications :-

a) Should have passed Standard VII and should not have acquired Graduation.

b) Ability to prepare the hooves of horses for fitting horse shoes, to make horse shoes and nails and to shoe horses.

c) Experience in shoeing horses either in Army or Civil.

Note: i) Those who claim equivalent qualification shall produce the respective Government Order to prove the claim at the time of One Time Verification.

ii) All the qualifications for the post must have acquired before the last date of receipt of application.

iii) KS&SSR Part II Rule 10(a) (ii) is applicable for selection to the post.

8. Mode of submitting applications:-

Candidates must register as per 'ONE TIME REGISTRATION' system on the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' for applying for the post. Candidates who have registered shall apply by logging in to their profile using their User- ID and password. Candidates shall click on the 'Apply Now' button of the respective posts in the Notification link for applying for a post. No application fee is required. The Photograph uploaded should be one taken after 31.12.2010. Name of the candidate and the date of photograph taken should be printed

legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking of the photograph. There is no change in other instructions regarding the uploading of photographs. Candidates shall take a print-out of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the User- ID for further communication with the Commission. Applications submitted is provisional and cannot be deleted or altered after submission. The applications will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for. **Candidates who have AADHAAR card should add AADHAAR card as I.D. Proof in their profile.**

9. **Address to which applications are to be sent :** www.keralapsc.gov.in.
10. **Last date of receipt of applications :** **02.12.2020** Wednesday upto 12 midnight.
11. If Written Test/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination. Appropriate disciplinary action as per KPSC Rules of Procedure Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.
