FIRST NCA NOTIFICATION

Applications are invited from qualified candidates belonging to reservation group of Latin Catholic/ Anglo-Indian Community of Kerala State against NCA vacancy for selection to the following post. Applications must be submitted online through the official website of the Kerala Public Service Commission after "ONE TIME REGISTRATION".

- 1. Department** : Kerala Higher Secondary Education
- 2. Name of Post** : Higher Secondary School Teacher (Junior)
Sanskrit
- 3. Scale of pay** : ₹ 32300-68700
- 4. Number of vacancies** : 01 (One) [NCA-LC/AI]

Note:- Higher Secondary School Teacher (Junior) means Part-time Higher Secondary School Teacher.

The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked for the above community but remain unfilled due to the paucity of candidates during the currency of the Ranked list published on 23.10.2019 for the post (Category No.248/2017 Gazette Date 18.08.2017).

- 5. Method of appointment** : Direct Recruitment from among Latin Catholic/ Anglo-Indian community only

Note:- Applications submitted by candidates belonging to community other than the above will be summarily rejected.

- 6. Age limit** : (20-43), Only candidates born between 02.01.1977 and 01.01.2000 (both dates included) are eligible to apply for this post [including para 2(i) of General Conditions].

[For other conditions regarding age relaxations, please see Para 2 of the General Conditions of the Gazette notification, except para 2(i)]

7. Qualifications:

1. Master's Degree in Sanskrit with not less than 50% marks from any of the Universities in Kerala or a qualification recognized as equivalent thereto in the respective subject by a University in Kerala.

2. (i) B.Ed Degree in Sanskrit acquired after a regular course of study from any of the Universities in Kerala or a qualification recognized as equivalent thereto by a University in Kerala.
 - (ii) In the absence of persons with B.Ed Degree in Sanskrit, B.Ed Degree acquired in the concerned faculty as specified in the Acts and Statutes of any of the Universities in Kerala.
 - (iii) In the absence of persons with B.Ed Degree as specified in item (i) and (ii) above, persons with B.Ed Degree in any subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognized as equivalent thereto by any of the Universities in Kerala.
3. Must have passed the State Eligibility Test (SET) for the post of Higher Secondary School Teachers conducted by Government of Kerala or by the agency authorized by the State Government.

Note:-

- (a) In the absence of B.Ed Degree holders, candidates having Masters Degree with not less than 50% marks and who have passed the State Eligibility Test will be considered. Preference will be given to those who have acquired Ph.D/ MPhil Degree or qualified at Junior Research Fellowship/National Eligibility Test. The teachers appointed under this provision will have to acquire B.Ed Degree at their own expense within five years from the date of entry in service.
- (b) Those who have passed Language Teachers Training Course are exempted from acquiring B.Ed qualification.
- (c) Persons who have acquired M.Ed in the subject concerned recognized by any University in Kerala are exempted from B.Ed qualification.

Exemptions:-

- (i) Those persons who have passed the State Level Eligibility Test (SLET) for the post of College Lecturers conducted by Government of Kerala are exempted from passing the State Eligibility Test for Higher Secondary School Teacher.
- (ii) Those persons who have passed the National Eligibility Test/ Junior Research Fellowship shall be exempted from passing the State Eligibility Test.
- (iii) Persons with Ph.D/ M.Phil/ M.Ed degree shall be exempted from passing the State Eligibility Test provided the M.Phil in the concerned subject should be one awarded by any of the Universities in Kerala or recognized as equivalent thereto by any of the Universities in Kerala.
- (iv) The teachers who have completed 10 (ten) years of approved teaching service at the High School level in the General Education subordinate service shall be exempted from passing the State Eligibility Test.

- (v) Relaxation of 5% marks in the Post Graduation will be given to Differently Abled Candidates as per G.O(Ms)No.288/15/Gl.Edn. Dated 13.11.2015.

Note:-

- (a) Rule 10 a (ii) of Part II KS & SSR is applicable.
- (b) Candidates who claim equivalent qualifications instead of qualification mentioned in the Notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
- (c) In the case of difference in original caste/ community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate/ Community Certificate at the time of certificate verification.

8 Mode of Submitting applications:

- (A) Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for the post. The photograph uploaded in the profile should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application from their one time registration profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application, candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is received as provisional and the details cannot be deleted or altered after submission. The application submitted not in accordance with the conditions stipulated in the notification will be summarily rejected in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for.

- (B) If written/ OMR/ Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
- (C) Appropriate disciplinary action as per Rules of Procedure Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.
- (D) Candidates who have AADHAAR card should add AADHAAR card as ID Proof in their profile.
