The candidates can avail only one chance after the Approval of Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Application for Rechecking received after the stipulated timewill not be entertained and Fee once remitted will not berefunded.

NOTE (3 :- Candidates who wish to a obtain photocopy of their OMR Answer Sheets (Part A & Part B) relating to thisselection shall remit a Fee of Rs. 335)- (Rupees Three hunderd and thirty five only) in any of the Treasuries in theState (Head of Account : 0051 - PSC - 800 - State PSC -99-Other Receipts). The duly filled in application in theprescribed form available from the Commission's website www.keralapsc.gov.in along with the original chalan shouldbe submitted to the Deputy Secretary (Examinations)-I Kerala Public Service Commission, Pattom P.O.,Thiruvananthapuram- 695004 within 45 (Forty Five) days from the date on which this Ranked List is uploaded in theCommission's website .. A copy of an answer sheet will be issued only once to a candidate.Copies of OMR answersheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answersheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receiptof applications is .17 .12 .2020. Applications received after the prescribed date will not be entertained.

NOTE (4) :- The entries put in column (8) are based on the Communities specified by the candidate in theirApplication forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the DeputySecretary (Examinations) -I, Kerala Public Service Commission, Thiruvananthapuram -695004 within one month fromthe Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to.
