NOTE (B): Candidate with SI.No. 171 was admitted provisionally for interview as per interim order in OA (EKM) No. 1880/2019 dtd 05/11/2019 is withheld subject to the disposal of above OP and further orders of the Commission.

**NOTE 1:** The Ranked List will be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years which ever is earlier. Candidates will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time ,if applicable ,against vacancies reported to the Commission during the pendancy of the list. As the advice for appointment depends on the occurrence of vacancies ,there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

**NOTE II:** Advice and appointment of the candidates who have been included in the Ranked List shall be subject to the final judgement of various OP's filed.

**NOTE III:** The marks of candidates in this Ranked List are hided as petitions before the Hon' ble High Court are pending to be ordered.

#### **NOTE IV:**

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit the fee of *Rs.335/-* in any of the Treasuries in the State (Head of account: 0051- PSC-800-State PSC-99-other receipts). The duly filled in application in the prescribed form (available from the Commission's website <a href="https://www.keralapsc.gov.in">www.keralapsc.gov.in</a>) along with the original chalan should be submitted to The District Officer, Kerala Public Service Commission District Office, Kannur within 45 days from the date on which this ranked list is uploaded in the Commission's Website. A copy of an answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is 18.12.2020. Applications received after the prescribed date will not be entertained.

#### NOTE V:

A period of 45 days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which this Ranked List is uploaded in the website. The candidates can avail only one chance. "Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's Website <a href="https://www.keralapsc.gov.in">www.keralapsc.gov.in</a> or photocopied there from. Applications submitted in any other manner will not be considered." The application for rechecking, along with original chalan receipt for the prescribed fee of **Rs.85/-** under the head of account "0051 - PSC 105 State PSC 99 – Examination Fee", addressed to The District Officer, Kerala Public Service Commission District Office, Kannur should reach the office on or before 18.12.2020. Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.

#### **NOTE VI:**

"Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a notarized affidavit and a self attested copy of an ID Proof bearing photograph as enlisted in the General conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised".
