FIRST NCA NOTIFICATION

Applications are invited online only exclusively from qualified candidates belonging to the reservation group of communities of Kerala State viz Latin Catholic/Anglo Indian for the selection to the following post. Applications shall be submitted through the official website of the Commission after ONE TIME REGISTRATION. Candidates who have registered can apply through their profile.

Candidates who have AADHAAR Card should add AADHAAR as I.D proof in their profile

- 1 Name of concern : **Kerala Land Development Corporation Limited**
- 2 Name of Post : Overseer Gr.II/Draftsman Gr.II (I NCA-LC/AI)
- 3 Scale of pay : ₹ 6680 – 10790/-
- 4 No of Vacancies : **1 (One) – (LC/AI)**

Note:

The number of candidates to be included in the Short List/Probability List of the above post will be decided as per the availability of admitted applications.

The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancy earmarked for above community during the currency of the Ranked List published on 08.08.2017 (Category No. 257/2013) or three years from the date of Publication of this NCA ranked list whichever is earlier.

The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of the candidates, provided that the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

- 5 Method of appointment : Direct Recruitment (from candidates belonging to LC/AI community only).
- 6 Age : 18-39, Only candidates born between 02.01.1981 and 01.01.2002 (both dates included) are eligible to apply for this post. (Including age relaxation to the community mentioned above).

Note: The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It would also be clearly specified in the Certificate that they were not working in the regular service of the concern.

7 Qualifications : Diploma in Civil Engineering recognized by the Govt. of Kerala or any equivalent qualifications.

Note: 1) Rule 10(a)ii of Part II KS&SSR regarding qualification is applicable for this selection.

2) Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

3) If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce community/NCLC certificate issued from concerned revenue authority and the Gazette Notification for the same at the time of certificate verification.

8 Mode of submitting applications

(a)

Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2010. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates

must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application.** The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, Community etc. have to be produced as and when called for.

- 9 Last date of receipt of applications : **20.01.2021** Wednesday upto 12.00 Midnight.
- 10 (a) Sub Paras (v), (viii), (ix), (x), (xi) and (xiii) in para 2 and para 5,5a and 7 of the General Conditions are not applicable to this post.
(b) The selection to the above concern will be subject to the rules and regulations made by them from time to time.
- 11 If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.

As per Rule 22 of the Rules of Procedure, appropriate disciplinary action will be taken against those candidates who submit application for the post with false claims of possession of prescribed qualification, experience etc. and give confirmation for examination, irrespective of the fact that they have appeared or not for the examination.
