Applications are invited online only from qualified candidates belonging to LA/AI community of Kerala State for appointment to the under mentioned post. Application must be submitted online through the Official website of the Commission after One Time Registration. Candidates who have already registered can apply through their profile.

1. Department : Health Services
2. Name of post : **Laboratory Technician Gr.II**
3. Scale of pay : ₹ 22200-48000/-
4. Number of vacancies : **District wise**
LC/AI -Malappuram - 01 (One)

(i) Ranked Lists will be prepared for the above District in pursuance of this notification. Ranked List thus prepared and published by the Commission shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community but remain unfilled due to paucity of candidates during the currency of the Ranked Lists published for the post in the above districts or for three years from the date of publication of the NCA Ranked List whichever is earlier.

- (ii) The Candidates belonging to the above reservation community shall submit application for the post to the above District where the vacancy is existing and note the name of that district against the relevant column in the online application.
- (iii) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O (MS) No.4/61/PD, dated 2.1.1961. Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

In case of change in caste noted in the SSLC Book, candidate must claim (iv) their original caste in the application and shall produce Non Creamy Layer Certificate issued by the Revenue Authorities and the gazette notification publishing the change of caste at the time of OTR verification for selection to the above post.

5. Method of appointment :- Direct Recruitment (From candidates belonging to LC/AI Community of Kerala State only)

Note: Applications submitted by candidates belonging to the communities other than those belonging to the LC/AI Community will be summarily rejected. No rejection memo will be issued to these candidates.

6. Age Limit 18-39 . Only Candidates born between 02.01.1981 and 01.01.2002 (both dates included) are only eligible to apply for this post (Including the relaxation as per para 2(i) of the General Conditions).

Note :- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification (except para 2(i)).

7. **Qualifications:-**

(a) **General**

(i) A pass in Pre-Degree or equivalent examination with not less than 50% marks or B grade in Science subjects. Relaxation of 5% marks to Socially and Educationally Backward communities who come under the purview of G.O (P) No.208/66/PD dated 21-05-1966 and subsequent orders/amendments.

(ii) SSLC or equivalent for Ex-servicemen who have passed Class I Blood Transfusion Assistant Test and have put in not less than 15 years service in the Armed Forces.

(b) **Technical**

A pass in one year Medical Laboratory Technician's Training Course conducted by the Medical Colleges in Kerala or by the Public Health Laboratory, Thiruvananthapuram or any qualification equivalent there to.

Note:- (i) In the case of persons who have completed Degree course in Science, 'B' Grade in Pre-degree examination will not be insisted.

(ii) KS&SSR Part II Rule 10 (a) (ii) is applicable for selection to this post.

8. **Mode of submitting Applications :-**

Candidates must register as per "ONE TIME REGISTRATION" with the Official Website of Kerala Public Service Commission, viz, www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be one taken after 31/12/2010. Name of the candidate and the date of

taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking the Photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application.** The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Original Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for.

9. Last date of receipt of applications : **20.01.2021** Wednesday upto 12 midnight.
10. If Written Test/OMR/Online Test is conducted as a part of this selection, Candidates shall submit a confirmation for writing the examination through their One Time Registration Profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it. **Candidates who have Aadhar Card should add Aadhar Card as I.D Proof in their profile.**
11. Appropriate disciplinary action as per Rule 22 of the KPSC Rules of Procedure, shall be initiated against those candidates who submit application with bogus claims of qualification regarding education, experience etc and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.
