**NOTIFICATION**

The following is the Ranked list of candidates for the post of **Lower Division Typist (Part II - By Transfer Recruitment) (Category No. 281/18)** in **Various Departments in Kannur District on Rs. 19,000-43,600/-** found suitable by the Commission and arranged in the order of merit based on the marks secured in the Objective Type (OMR) Test held on 06.07.2019. This Ranked List is brought into force with effect from **10.11.2020**.

The candidates from this list will be advised for appointment against vacancies reported to the Commission in accordance with the rules and orders regarding rotation as amended from time to time. 10 % of the vacancies reported to the commission will be filled up by the candidates included under Part II (By Transfer). In case the candidates included in the Ranked List couldn't secure appointment before the expiry of the Ranked List, the names of such candidates will be included at the top of the new Ranked List of the Low paid Employees drawn up by the Commission subsequently in the same order and they will be advised for appointment accordingly vide G.O(P)No.39/89/P&ARD dated 08/12/1989.

According to the existing procedure, revaluation of answer script is not allowed. But answer scripts will be re-checked to see that all the answers are valued and that there is no mistake in the totaling of marks for various answers if the candidates apply for rechecking, remitting the prescribed fee of Rs. 85/- (Rupees Eighty Five only) in any one of the Treasuries in the State under the Head of Account **"0051 PSC 105 State PSC 99 Examination Fee"**. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or photocopied there from. Applications submitted in any other manner will not be considered. The application for re-checking along with the original chalan receipt should reach the **District Officer, Kerala Public Service Commission District Office, Civil Station PO, Kannur - 670 002** within 45 days from the date on which this Ranked List is uploaded in the Commission's website. Application for rechecking received after the prescribed time limit or not in the prescribed form will not be entertained. The fee once remitted will not be refunded on any account. In the case of candidates who sent applications for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office.

Candidates who wish to obtain a photocopy of their OMR Answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs. 335/- (Rupees Three hundred and Thirty five only) by way of chalan in any of the treasuries in the State under the Head of Account “**0051- PSC-800 State PSC - 99 Other Receipts**”. The duly filled up application in the prescribed form (available in the Commission’s website [www.keralapsc.gov.in](http://www.keralapsc.gov.in)) along with the original chalan should be submitted to the **District Officer, KPSC District Office, Civil Station PO, Kannur** within 45 days from the date on which this Ranked List is uploaded in the Commission's website. A copy of answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

The Last date for the receipt of applications for rechecking/obtaining Photocopy of the answer scripts is **20.01.2021**. Application for rechecking/obtaining Photocopy, received after the prescribed time limit and not in the prescribed form will not be entertained.

*“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.”*

Since a common OMR Test with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and marks of OMR Test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test. The result of rechecking of OMR Answer Scripts will be intimated in due course. But photocopy of OMR Answer scripts will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the Common Test.

The A part and B part of OMR Scripts will be destroyed after completing 6 months period from the date of finalisation of Ranked List ie, on **09.05.2021**.
