The uploaded photo will be having a validity of ten years from the date of photograph taken.

Note:- The above Vacancies are now in existence. The Ranked list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancies and also for the vacancies reported for special recruitment for SC/ST & ST only during pendency of the list. Absence of Scheduled Tribe candidates in these lists that fresh notification for Scheduled Tribes for vacancies reserved exclusively for them will issued.

4 Method of Appointment :

Direct Recruitment (Sl. No. 1&5 - Special Recruitment from Scheduled Caste / Scheduled Tribes Sl. No. 2, 3, 4, 6, 7 Special Recruitment from among Scheduled Tribes Only)

Note:- Applications received from candidates other than Scheduled Caste/Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

5 Age : 20 – 45 Only Candidates born between 02.01.1975 and 01.01.2000 (both dates included) are eligible to apply for this post. No other age relaxation will be allowed.

Note:- In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

(I) Masters Degree in the concerned subject with not less than 45% marks from any of the Universities in Kerala or a Qualification recognised as equivalent thereto in the respective subject by any University in Kerala.

(II)(1) B.Ed in the concerned subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognised as equivalent thereto by a University in Kerala.

(2) In the absence of persons with B.Ed. Degree in concerned subject, B.Ed. degree acquired in the concerned faculty as specified in the Acts and Statutes of any of the Universities in Kerala.

(3) In the absence of persons with B.Ed. Degree as specified in item (1) and (2) above, persons with B.Ed. Degree in any subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognised as equivalent thereto by any of the Universities in Kerala.

OR

M.Sc.Ed in the concerned subject with not less than 45% of marks from any of the Regional Institutes of Education sponsored by National Council for Education Research & Training (NCERT)

III Must have passed the State Eligibility Test (SET) for the post of Higher Secondary School Teacher conducted by the Government of Kerala or by the Agency authorized by the State Government.

Note: Persons who have acquired M.Ed in the subject concerned recognized by any university in Kerala are exempted from B.Ed qualification.

(I) Masters Degree in the concerned subject with not less than 45% marks from any of the Universities in Kerala or a Qualification recognised as equivalent thereto in the respective subject by a University in Kerala.

(II)(1) B.Ed in the concerned subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognised as equivalent thereto by a University in Kerala.

(2) In the absence of persons with B.Ed. Degree in concerned subject, B.Ed. degree acquired in the concerned faculty as specified in the Acts and Statutes of any of the Universities in Kerala.

(3) In the absence of persons with B.Ed. Degree as specified in item (1) and (2) above, persons with B.Ed. Degree in any subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognised as equivalent thereto by any of the Universities in Kerala.

III) Must have passed the State Eligibility Test (SET) for the post of Higher Secondary School Teachers conducted by the Government of Kerala or by the Agency authorized by the State Government.

Note:- Persons who have acquired M.Ed in the subject concerned recognized by any university in Kerala are exempted from B.Ed qualification.

(i) Masters Degree in the concerned subject with not less than 45% marks from any of the Universities in Kerala or a Qualification recognised as equivalent thereto in the respective subject by any University in Kerala.

(ii)(1) B.Ed in the concerned subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognised as equivalent thereto by a University in Kerala.

(2) In the absence of persons with B.Ed. Degree in concerned subject, B.Ed. degree acquired in the concerned faculty as specified in the Acts and Statutes of any of the Universities in Kerala.

(3) In the absence of persons with B.Ed. Degree as specified in item (1) and (2) above, persons with B.Ed. Degree in any subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognised as equivalent thereto by any of the Universities in Kerala.

iii) Must have passed the State Eligibility Test (SET) for the post of Higher Secondary School Teacher conducted by the Government of Kerala or by the Agency authorized by the State Government.

Note (1)- In the absence of B.Ed. Degree holders, candidates having Masters Degree with not less than 45% marks and who have passed State Eligibility Test will be considered. Preference will be given to Ph.D degree or M.Phil Degree or qualified at Junior Research Fellowship/National Eligibility Test. The teachers appointed under this provision will have to acquire B.Ed. Degree at their own expense within five years from the date of entry in service.

(2) Those who have passed Language Teacher Training Course (LTTC) are exempted from acquiring B.Ed. qualification.

(3) Persons who have acquired M.Ed in the subject concerned recognized by any university in Kerala are exempted from B.Ed qualification.

Exemptions for All Posts (Sl.Nos. 1 to 7)

1) Those persons who have passed the State Level Eligibility Test for the post of College Lecturers conducted by Government of Kerala are exempted from passing the State Eligibility Test for Higher Secondary School Teacher.

2) Those persons who have passed the National Eligibility Test/Junior Research Fellowship shall be exempted from passing the State Eligibility Test.

3) Persons with Ph.D./M.Phil/M.Ed. Degree shall be exempted from passing the State Eligibility Test, provided the M.Phil. in the concerned subject should be one awarded by any of the Universities in Kerala or recognised as equivalent thereto by any of the Universities in Kerala.

4) The teachers who have completed 10 (Ten) years of approved teaching service at the High School level in the General Education Subordinate Service shall be exempted from passing the State Eligibility test for Higher Secondary School Teacher.

Note: Higher Secondary School Teacher (Junior) means Part-Time post of Higher Secondary School Teacher.

Note : 1. Rule 10(a)(ii) of part II of KS&SSR regarding qualification is applicable for all posts.

2. Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

3. If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce Community Certificate issued from concerned revenue authority and the Gazette Notification for the same at the time of certificate verification.

4. Appointed candidate will be on probation for a total period of two years on duty within a continuous period of three years.

7 Mode of Submitting application:

Candidates must register as per 'ONE TIME REGISTRATION' with the official website of Kerala Public Service Commission www.keralapsc.gov.in

before applying for the post. Candidates who have already registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of each application, the candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is treated as provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for. The profile correction made by the candidate or in the office of the Kerala Public Service Commission on request after the last date fixed for receipt of application will not be reflected in the application. Such corrections will be in effect on the date on which corrections have been made.

Those who have Aadhar Card should add Aadhar card as ID Proof in their profile.

- 11 Appointments are made on the basis of the rank secured in the ranked list of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O.(MS) No. 142/72/PD dated 13/04/1972, G.O.(MS) No. 309/73/PD dated 29/11/1973, G.O.(P) No. 21/76/PD dated, 17.01.1976 and G.O. (P) No.25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled Caste/Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.**
- 12 If written/OMR/Online Test is conducted as part of this selection candidates shall submit a confirmation for writing the examination through their One Time Registration profile . Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calender itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.**
- 13 Appropriate Disciplinary action as per KPSC Rules of Procedure 1976 Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education,experience etc.,and submit**

confirmation for writing examination, irrespective of whether they are present or absent for the examination.
