## 7. Qualifications:

- 1) M.Sc (Nursing) or B.Sc Nursing (Basic or Post Basic) from a recognized University.
- 2) Certificate of Registration with the Kerala Nurses and Midwives Council as Nurse & Midwife in the case of women candidates or as Nurse in the case of male candidates.

### Note:

- 1) Every person appointed as Nursing Tutor be on probation for a total period of two years on duty within a continuous period of three years.
- 2) Every person appointed as Nursing Tutor shall during the period of probation, pass the Account test for Executive Officers (Kerala) or Account Test (Lower), if he/ she has not already passed the tests.

- **Note:** 1 Candidates who claim equivalent qualifications instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of Verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
  - 2 In the case of difference in original caste/community claimed in the application and that entered in S.S.L.C book, the candidates shall produce a Gazette Notification in this regard, along with Non Creamy layer Certificate/Community Certificate at the time of Certificate Verification.

No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. They must quote the User- ID for further communication with the Commission, Application submitted is provisional and cannot be deleted or altered after submission. - **(b)** If a Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation on writing the examination through their One Time Registration Profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. Appropriate disciplinary action

as per Rules of Procedure Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and submit confirmation for writing the examination, irrespective of weather they are present or absent for the examination.
