Note:-(4) Candidates included in the Unified List should present and produce in person the Original Documents for One Time Verification Date, Time and venue of OTR Verification will be published shortly through OTR Profile.

Note:-(5) Date, Time and venue of Dictation Test will also be intimated through OTR Profile.

Note :-(6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note:-(7) Scheduled Castes/Scheduled Tribe Candidates included in the List are required to produce Community Certificate (in form III/Digitally signed) issued by the concerned Revenue Authority and candidates belonging to other Reservation Groups should produce Non Creamy Layer Certificates issued by the Village Officer at the time of OTR Verification.

Note:-(8) Copy of answer scripts of the OMR Test held on 06-07-2019 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER II(2) 4933/19/EW dated 12-12-2019.
