- (i) Conventional type applications will be summarily rejected. Candidates shall apply online only by One Time Registration to www.keralapsc.gov.in.
- (ii) A separate Ranked List will be prepared for each district in pursuance of this notification. The Ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier.
