Note :- (7) Copy of answer scripts of the OMR Test held on **04-11-2020** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates are invalidated for the above mentioned post as per the notification no:ERIVB(2)617/2021/EW dated 17.04.2021.
