Applications are invited online only through One Time Registration from qualified Ex-servicemen candidates belonging to the Muslim, Dheevera & Scheduled Caste Communities of Kerala State for appointment to the undermentioned post.

Note:-

- (i) The number of candidates to be included in the short list/probability List of the above post will be decided as per the availability of admitted applications.
- ii) The above vacancy is now in existence. The Ranked List published as per this Notification will be valid until candidates are advised and appointed against the vacancy notified due to paucity of candidates belonging to Muslim, Dheevera, Scheduled Caste Communities during the currency of the Mother Ranked List (Cat No 469/10) published on 09/05/2016 or three years from the date publication of this NCA Ranked List whichever is earlier. This is the Fifth NCA Notification published due to the non- availability of candidates as per issuance of 1<sup>st</sup> NCA Notification in Gazette dated 28.02.2017 as Cat. Nos.15/2017, 16/2017 and 18/2017, 2<sup>nd</sup> NCA notification in Gazette dated 26.07.2018 as Cat.Nos.105/2018,106/2018 and 108/2018, 3<sup>rd</sup> NCA Notification in Gazette dated 31.12.2019 as Cat .Nos 562/2019, 563/2019 and 565/2019, 4<sup>th</sup> NCA Notification in Gazette dated 31/12/2020 as Cat Nos. 415/2020,416/2020,417/2020.

- (iii) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

- 5 Method of Appointment : Direct Recruitment from Ex-Servicemen only (Candidates belonging to Muslim , Dheevera, SC Community only. )

**Note 1:** - In the absence of Scheduled Caste candidates Scheduled Tribe candidates will also be considered.

**Note 2:** - Application received from the communities other than the communities mentioned above will be summarily rejected.

- 6 Age : Muslim & Dheevera:- 18-49 Only candidates born between 02.01.1972 and 01.01.2003 (both dates included) are eligible to apply for this post. Including relaxation as per para 2(i)  
SC:-18-50.Only candidates born between 02.01.1971 and 01.01.2003 (both dates included) are eligible to apply for this post. Including relaxation as per para 2(i)

**Note:-** The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of Five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It would also be clearly specified in the certificate that they were not working in the regular service of the concern.

## 7. Qualification:

1. SSLC failed (Application from those who have passed SSLC shall not be considered.)
2. Not less than 3 years service in the Armed forces viz. Army/ Navy/ Air Force
3. Cycling
4. Must possess Valid License in driving light Motor Vehicles.

Note: Differently Abled Candidates and Women are not eligible to apply for the post.

Note:

- (1) Rule 10(a)ii of Part II of KS&SSR is applicable.
- (2) Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
- (3) If the caste of a candidate of difference in original caste/community claimed in the application and that entered in the SSLC book the candidates shall produce the Gazette Notification in this regard , along with Non Creamy Layer certificate /Community Certificate at the time of certificate verification.
- (4) Appropriate disciplinary actions as per KPSC Rules of Procedure 1976 Rule 22, will be initiated against those candidates, who submit applications with bogus claims of qualification regarding education, experience etc. and submit confirmation for writing examination irrespective of whether they are present or absent for the examination .

## 8 Method of submitting Applications

(a) Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2011. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile

candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application.** The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, Community etc. have to be produced as and when called for.

**(b)“Candidates who have Aadhaar Card should add Aadhaar Card as ID proof in their profiles”.**

(c) "If written/OMR/Online Test is conducted as part of this selection candidates shall submit a confirmation for writing the examination through their One Time Registration profiles. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The application of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of admission tickets will be published in the examination calendar itself. Information in this regard will given to the candidates in their respective profiles and in the mobile phone number registered in it."
