Applications are invited online only by 'One Time Registration' from qualified candidates belonging to the following reservation communities of Kerala State for selection to the following Post. Applications shall be submitted through the official website of Commission (www.keralapsc.gov.in) after ONE TIME REGISTRATION. Candidates who have already registered can apply through their profile. Candidates who have AADHAAR card should add AADHAAR as ID proof in their Profile

1. **Department** : **Police**
2. **Name of Post** : **Woman Police Constable (Woman Police Battalion)**

Note: Male candidates and differently abled candidates are not eligible to apply in response to this notification

3. **Scale of Pay** : **₹ 22,200-48,000/- (PR)**

**The recruitment to the post of Woman Police Constable will only be to the Woman Police Battalion and the vacancies occurring in the districts will be filled up by transferring the officers on the basis of advice/rank seniority. (G.O.(Rt)No.1484/2017/Home dated 05.06.2017.)**

Note: i) Applications submitted by candidates belonging to the communities other than notified will be summarily rejected. No rejection memo will be issued to such candidates.

ii) In the case of difference in original caste/community claimed in the applications and that entered in SSLC book, the candidate shall produce a gazette notification in this regard along with Non Creamy Layer Certificate/Caste Certificate at the time of certificate verification

iii) The above vacancies are now in existence. Ranked list will be prepared for each community in pursuance of this notification. The Ranked List published as per this notification shall remain in force for a period of one year from the date of publication of Ranked List or until candidates are advised and appointed against the vacancies earmarked for the above communities, but remain unfilled due to paucity of candidates during the currency of the Ranked List published from the post as detailed below, whichever is earlier.

**5. Method of appointment : Direct Recruitment (Statewide)**

From the women candidates belonging to SCCC & Muslim communities only.

**6. Age limit** : **18-29.** Candidates born between 02.01.1992 and 01.01.2003 (both dates included) are eligible to apply for this post.

(Including the relaxation as per para 2(i) in part II of General conditions).

Note: Candidates belonging to Schedule Caste Converted to Christian Community, who have converted to Christianity from SC after attaining 18 years and children of such parents ie. candidates born between 02.01.1990 and 01.01.2003 are eligible to apply for this post (both dates included) and their age limit is 18-31.

(For other conditions regarding age relaxation, please see Para(2) of the General Conditions, except Para 2(i), under Part II of this notification.)

**7. Qualification:-**

(a) **Educational:** Pass in HSE examination (Plus Two) or its equivalent

Note:

(i) Rule 10 (a) (ii) of Part II of the KS & SSR is applicable.

(ii) Candidates who claim equivalent qualification shall produce the relevant Government order to prove the claim at the time of One Time Verification or as required by the Commission.

(b) **Physical Qualifications:**

- (i) Height : A minimum of 157cm.
- (ii) Eye Sight: Must be certified to possess the visual standards specified below without glasses.

Note:

(i) Each eye must have a full field of vision. Colour blindness, squint or any morbid conditions of the eye or lids of either eye will be deemed to be a disqualification.

(ii) Must be free from apparent physical defects like knock-knee, flat foot, varicose vein, bow legs, deformed limbs, irregular and protruding tooth, defective speech and hearing.

- (c) Must qualify in any five events out of eight events specified below of the National Physical Efficiency, One Star Standard Test.

Note: Physical measurement of candidates will be taken at the time of physical efficiency test and those who do not possess the prescribed physical measurement will not be admitted for the physical efficiency test. **If accidents or injuries happen to a candidate while participating in the physical efficiency test, she will not be given further chance to participate in the test.** The candidates should produce at the time of physical efficiency test, a Medical Certificate in original in the form prescribed hereunder, certifying to their physical fitness and eye sight without glasses. The Medical Certificate should be one obtained from a Medical Officer under the Government not below the rank of an Assistant

Surgeon/ Junior Consultant. The Medical Certificate should also be uploaded at the time of certificate verification.

Note: Details regarding standards of vision should be clearly stated in the Certificate as given above and vague statement such as Vision Normal/good will not be accepted. Specification for each eye should be stated separately. If the specifications are not as indicated above, the officer issuing the Certificate should certify whether the candidate has got better standards of vision or worse standards of vision as the case may be, otherwise the Certificate will not be accepted.

**8. Mode of submitting applications:**

Candidates must register as per 'ONE TIME REGISTRATION' with the official Website of Kerala Public Service Commission ([www.keralapsc.gov.in](http://www.keralapsc.gov.in)) before applying for the post. Candidates who have already registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken on or after 31/12/2011. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all the requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. **Candidates shall take a printout of the application by clicking the link 'Applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the printout of the application.** Candidates are responsible for the correctness of their personal information and secrecy of password. Before the final submission of the application, candidates must ensure the correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is received as provisional and the details cannot be deleted or altered after submission. The application submitted not in accordance with the conditions stipulated in the notification will be summarily rejected in due course of processing. Documents to prove qualification, Experience, Community, age etc have to be produced as and when called for.

9. Appropriate Disciplinary action as per Rules of procedure Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc and submit confirmation for writing examination irrespective of whether they are present or absent for the examination
10. **Last date of receipt of applications: 19.01.2022** Wednesday upto 12 midnight.
11. If Written Test/OMR/Online Test is conducted as a part of the selection candidate shall submit a confirmation for writing the examination through One Time Registration Profile. Such candidates alone can generate and download the admission tickets in the last fifteen days till the date of test. The applications of candidate who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of admission tickets will be published in the examination calendar itself. Information in this regard

will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
