The following is the list of candidates for selection to the post of **COOK (NCA-Muslim) - First NCA Notification** - on **Rs.16500 - 35700** in **SCHEDULED CASTE DEVELOPMENT DEPARTMENT** in **Alappuzha District**, found suitable by the Commission and arranged in the order of merit based on the OMR Test held on **17/07/2021**. This Ranked List is brought into force with effect from **27.01.2022** and will be valid until the candidates are advised and appointed against the vacancies notified due to the paucity of candidates belonging to Muslim community during the currency of the Mother Ranked list, R/L No. 816/17/DOA dated 23.08.2017 (Cat. no. 566/13) or three years from the date of publication of this NCA Ranked List, whichever is earlier.

NOTE (1) :- The Ranked List shall remain in force until candidates are advised and appointed against the NCA vacancies arose due to the paucity of candidates belonging to Muslim community during the currency of the Parent Ranked list, published for the post on 23.08.2017 (Cat. no. 566/13) or three years from the date on which the NCA Ranked List is brought into force, whichever is earlier. Candidates from the Ranked List will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in the Ranked List will secure appointment. The candidates remaining in the Ranked List at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the List.

NOTE (2) :- The entries put in column (5) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to **the District Officer, Kerala Public Service Commission District Office, Alappuzha - 688001** within one month from the Date of publication of the List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the List.

NOTE (3) :- Since a common OMR test was conducted for this post, the marks awarded to the candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists which will be finalised on the basis of the common test. The result of rechecking of OMR answer scripts will be intimated in due course. But photocopy of the OMR scripts will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.

NOTE (4) :- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall remit a Fee of **Rs. 335/- (Rupees Three Hundred and Thirty Five only)** by way of chalan in any of the Treasuries in the State (**Head of Account : 0051 - PSC - 800 - State PSC -99 Other Receipts**). The duly filled in application in the prescribed form (available from the Commission's website www.keralapsc.gov.in) along with the original chalan should be submitted to **The District Officer, K.P.S.C District Office, Alappuzha - 688001** within 45 (Forty Five) days from the date on which this Ranked List is uploaded in the Commission's website. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is 23.03.2022. Applications received after the prescribed date will not be entertained.

NOTE (5) :- A period of 45 (Forty Five) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which this Ranked List is uploaded in the Commission's website. The candidates can avail only one chance. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of various offices of the commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's website www.keralapsc.gov.in or photocopied therefrom. Applications submitted in any other manner will not be considered. The Application for rechecking, alongwith original chalan receipt for the prescribed fee of **Rs. 85/- (Rupees Eighty Five Only)** under the **Head of Account : 0051 - PSC - 105 - State PSC -99 Examination Fee** addressed to **The District Officer, K.P.S.C District Office, Alappuzha - 688001** should reach the office on or before 23.03.2022. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.

NOTE (6) :- "Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal alongwith a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he is to be advised."

NOTE (7) :- The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of Ranked list, i.e. on 26.07.2022.
