The following is the list of candidates for selection to the post of **Lower Division Clerk(From Ex-servicemen only) (FIRST NCA SC)** on **Rs. 19000-43600** in **NCC/Sainik Welfare Department in Idukki District**, found suitable by the Commission and arranged in the order of merit for recruitment against the NCA vacancy for SC community based on the OMR Test held on 07/10/2021. This Ranked List is brought into force with effect from **09/05/2022** and will remain in force until candidates are advised and appointed against the NCA vacancies arose due to the paucity of candidates belonging to SC community during the currency of the Mother Ranked List published on 27/03/2018 (Category No.415/13) or three years from the date on which this NCA Ranked List is brought into force, whichever is earlier.

NOTE (1) :- According to the existing procedure, revaluation of Answer Script is not allowed. But, Answer Scripts will be rechecked to see that all answers are valued and there is no mistake in the totalling of the marks. A period of 45 days time to apply for rechecking of answer Scripts will be allowed to candidates with effect from the date on which this Ranked List is uploaded in the Commission's website. The candidates can avail only one chance after the approval of the Ranked List. Application for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy, or downloaded and printed in A 4 size paper from the Commission's website www.keralapsc.gov.in or Photocopied there from. Applications submitted in any other manner will not be considered. The application for rechecking along with original Chalan receipt in the prescribed fee of Rs. 85/- (Rupees Eighty five Only) under the Head of Account "0051 - PSC - 105 State PSC 99 - Examination Fee" addressed to the District Officer, Kerala Public Service Commission, District Office, Kattappana, Idukki-685508 should reach the office on or before 03/07/2022. Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded. Application for rechecking received from the candidates whose Answer scrips have been invalidated will not be considered.

NOTE (2) :- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall remit a Fee of Rs. 335/- (Rupees Three Hundred and thirty five only) in any of the Treasuries in the State (Head of Account : 0051 - PSC - 800 - State PSC -99-Other Receipts). The duly filled in application in the prescribed form available from the Commission's website www.keralapsc.gov.in along with the original chalan should be submitted to the the District Officer, Kerala Public Service Commission, District Office, Kattappana, Idukki-685508, within 45 (Forty Five) days from the date of upload of the Ranked List in the official website of the Commission. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is 03/07/2022. Applications received after the prescribed date will not be entertained.

NOTE (3) :- Any candidate can relinquish his right for appointment in writing duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he is to be advised.

NOTE (4) :- Since a common OMR test with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA notifications) which will be finalised on the basis of the common test. The result of rechecking of OMR answer scrips will be intimated in due course. But photocopy of the OMR answer scripts will be issued only after the publication of the Ranked lists for all the posts finalised on the basis of the common test.

NOTE (5) :- The A part and B part of OMR scrips will be destroyed after completing 6 months period from the date of finalisation of last Ranked list included in the common test.

NOTE (6) :- The 'Remarks-Willing/Not Willing' in the ranked list denotes the willingness of the candidates to be appointed to the security posts like Store Keeper, Cashier etc. which are governed by Fidelity Guarantee Policies.
