Applications are invited online only from qualified candidates for appointment in the undermentioned post in Kerala Government Service. Before applying the post the candidates should register as per the One Time Registration through the official website of Kerala Public Service Commission. Candidates who have already registered can apply through their profile.

The above vacancy is now in existence. The Ranked list published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the aforesaid vacancy and also against the vacancies reported to the Commission during the period of currency of the list.

Note: 3% of the vacancies for the post shall be reserved for differently abled candidates with Loco motor Disability/ Cerebral Palsy and Blindness/Low vision as per G.O(P) No. 1/13/SJD dated 03.01.2013. Differently Abled candidates with Hearing Impairment are not identified as suitable for this post and hence they are not eligible to apply for this post.

5.Method of appointment-Direct Recruitment

6.Age limit- 22-36 ie; candidates who are born between 02/01/1986 and 01/01/2000 (both dates included) are only eligible to apply for this post with usual relaxation to Scheduled Castes, Scheduled Tribes and Other Backward Communities. (For other conditions regarding the age relaxation please see Para (2) of Part II General Conditions.)

7.Qualifications-First or Second class in B A (Music)/ Bachelor of Performing Arts (Vocal) by a recognized university/Institution.

Note:-

1) Rule 10(a) ii of Part II of KS & SSR is applicable.

2) Candidates who claim equivalent Qualification instead of qualification mentioned in the notification shall produce the relevant Government order to

prove the equivalency at the time of certificate verification; then only such qualification shall be treated as equivalent to the prescribed qualification.

3) In the case of difference in Caste/Community claimed in the application and that entered in the S.S.L.C book ,the candidates shall produce a gazette notification in this regard ,along with NCLC/Community Certificate at the time of certificate verification.

4) **Probation:-** Every person appointed to the post shall be on probation for a total period of 2 years on duty within a continuous period of 3 years, from the date of joining duty.

8. Mode of submitting Application:-

- a. Candidates must register as per “ONE TIME REGISTRATION” system on the official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by logging to their profile using their User-ID and password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for the post. The Photograph uploaded should be the one taken after **31.12.2012**. Name of the candidate and the date of taking photograph should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. From 01.01.2022 candidates who register first time should upload photo taken within 6 months from the date of their registration. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information on their profile. They must quote User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the commission, regarding the application should be accompanied with the print out of the application.** The applications will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, Experience, Community, Age etc. have to be produced as and when called for. The profile correction made by the candidates themselves or in the office of Kerala Public Service Commission on request after the last date fixed for the receipt of application will not be reflect in the application. Such corrections will be effective only on the date on which the corrections have made.

- b. If a Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation on writing the examination through their one time registration profile. Such candidates alone can generate and download the admission tickets in the last 15 days till the date of test. The application of the candidates who do not submit confirmation within the stipulated period will be rejected summarily. The period regarding the submission of confirmation and availability of admission tickets will be published in the examination calendar itself. Information in this regard will be given to the candidates in their respective profiles and the mobile phone number registered in it.
- c. Appropriate disciplinary action as per the KPSC Rules of Procedure, Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.
- d. Candidates who have AADHAAR card should add AADHAAR Card as I.D Proof in their profile.
