Note:- The above Vacancies are now in existence. The Ranked list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancy and also for the vacancies reported for special recruitment for ST only during pendency of the list.

5 Method of: Direct Recruitment (Special Recruitment from Scheduled Tribes only)

Note:- Applications received from candidates other than Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6 Age : 20-45,

Only Candidates born between 02.01.1977 and

01.01.2002

(both dates included) are eligible to apply for this post. No other age relaxation will be allowed.

Note:- In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7 Qualifications:

(I)Masters Degree in the concerned subject with not less than 45% marks from any of the Universities in Kerala or a Qualification recognised as equivalent

thereto in the respective subject by any University in Kerala.

- II (1) B.Ed in the concerned subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognised as equivalent thereto by a University in Kerala.
- (2) In the absence of persons with B.Ed. Degree in concerned subject, B.Ed. degree acquired in the concerned faculty as specified in the Acts and Statutes of any of the Universities in Kerala.
- (3) In the absence of persons with B.Ed. Degree as specified in items (1) and (2) above, persons with B.Ed. Degree in any subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognised as equivalent thereto by any of the Universities in Kerala.

OR

M.Sc.Ed in the concerned subject with not less than 45 percentage of mark from any of the regional institutes of education sponsored by National Council for Education Research & Training (NCERT).

III Must have passed the State Eligibility Test for the post of Higher Secondary School Teacher conducted by the Government of Kerala or by the Agency authorized by the State Government.

Note (1) Persons who have acquired M.Ed in the subject concerned recognized by any university in Kerala are excempted from B.Ed qualification.

Note(2)a. Candidates who have acquired Non-qualifying degrees viz.Ph.D/M.Phil/Post Doctoral Fellowship will be awarded weightage marks provided that such non-qualifying degrees shall be in the subjects pertaining to the basic qualifiation stipulated for the post. Weightage marks for non qualifying degrees for ranking will be awarded as detailed below:

Non-Qualifying M.Phil - 2 marks

Non-Qualifying Ph.D - 4 marks

Both M.Phil & Ph.D (Non-Qualifying) -5 marks

Post Doctoral Fellowship - 2 marks

Note(2)b. Non-Qualifying degree means the additional qualifiations which are earned apart from the qualifiations insisted on as essential qualifiations for the post. If Ph.D/M.Phil/Post Doctoral Fellowship is reckoned as necessary qualifiation for the post, weightage marks will not be awarded for it.

Exemptions

- 1) Those persons who have passed the State Level Eligibility Test for the post of College Lectures conducted by Government of Kerala are exempted from passing the State Eligibility Test for Higher Secondary School Teacher.
- 2) Those persons who have passed the National Eligibility Test/Junior Research Fellowship shall be exempted from passing the State Eligibility Test.

- 3) Persons with Ph.D./M.Phil/M.Ed. Degree shall be exempted from passing the State Eligibility Test provided the M.Phil. in the concerned subject should be one awarded by any of the Universities in Kerala or recognised as equivalent thereto by any of the Universities in Kerala.
- 4) The teachers who have completed 10 (Ten) years of approved teaching service at the High School level in the General Education Subordinate Service shall be exempted from passing the State Eligibility test for Higher Secondary School Teacher.

Note: Higher Secondary School Teacher (Junior) means Part-Time post of Higher Secondary School Teacher.

Probation: Appointed candidates will be on probation for a period of 2 years on duty within a continuous period of 3 years.

Note: 1. Rule 10(a)(ii) of part II of KS&SSR is applicable

- 2. Those candidates who have claimed equivalency for qualifications should produce the Government Order proving the same at the time of Certificate verification in order to consider as equivalent. Candidates claiming higher /eqivalent to the qualification for which equivalency is prescribed in the notification should produce equivalency certificate from concerened institution or Government order proving the equivalency.
- 3. If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce Community Certificate issued from concerned revenue authority and the Gazette Notification for the same at the time of certificate verification.

8 Mode of Submitting application:

Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion of the photograph uploaded. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking Photograph. Candidates who create their profile from 01.01.2022 should upload photograph with in the period of six months. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted

Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, Community etc. have to be produced as and when called for.

(P) No.25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.
- 13 If written/OMR/Online Test is conducted as part of this selection candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely.
