**NOTE (1)** :-The mark shown in the column (4) of the Ranked list is the Percentage of Marks secured in the Descriptive Test.

**NOTE (2)** :- The Ranked List of candidates published by the Kerala Public Service Commission in pursuance of this notification shall cease to be in force after one month from the date of commencement of training (Forest Range Officers Course) or 3 months from the date of coming into force of the ranked list whichever is later. Candidates from the Ranked List will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the Ranked List. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in the Ranked List will secure appointment. The candidates remaining in the Ranked List at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the Ranked List.

**NOTE (3)** :- According to the existing procedure, revaluation and rechecking of answer scripts is not allowed.

**NOTE (4)** :- Candidates who wish to obtain image and tabulation sheet of their answer sheet relating to this selection shall remit the fee of **Rs.335/- (Rupees Three Hundred and Thirty Five Only)** per paper in any of the Treasuries in the State (**Head of account: 0051 PSC-800-State PSC-99 other receipts**). The duly filled in application in the prescribed form (available from the Commission's website ([www.keralapsc.gov.in](http://www.keralapsc.gov.in))) along with the original chalan should be submitted to **The deputy Secretary (Examinations), Kerala Public Service Commission, Pattom, Thiruvananthapuram-695004** within 45 days from the date on which this Ranked list is uploaded in the Commission's Website (on or before **07/08/2022**). Copy of an answer sheet will be issued only once to a candidate. Copies of answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

**NOTE (5)** :- The entries put in column (9) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the Deputy Secretary (Examinations) , Kerala Public Service Commission, Thiruvananthapuram - 695004 within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

**NOTE (6)** :- Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
