Note :- (6) SC/ST Candidates included in the Short List are required to produce Community Certificate,the candidate belonging to Other Backward Communities are required to produce Non Creamy Layer Certificate as per G O (P) No:81/09/SC/ST/DD dated 26.09.2009,Differently abled candidates are required to produce Disability Certificate concerned and the candidates who have EWS claim are required to produce EWS Certificate at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **28-10-2021** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
