- NOTE 1 The entries put in column (8) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. publication of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised".
