Physical Measurement and a Physical Efficiency Test are also specified in the Gazette Notification as part of the selection process.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O(P)No.81/09/SCSTDD dated 26/09/2009 along with other documents at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **26-02-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
