Applications are invited Online only through One Time Registration from qualified candidates for appointment in the under mentioned post in Kerala Government Service. Before applying for the post the candidates should register as per One Time Registration through the official website of Kerala Public Service Commission. Candidates who have already registered can apply through their profile.

1. **Department** : **Kerala General Education (DIET)**
2. **Name of Post** : **Lecturer in Vocational Education**
3. **Scale of pay** : **₹ 55200 – 115300/-**
4. **Number of vacancy** : **04 (Four)**

The above vacancies are now in existence. The Ranked list published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against aforesaid vacancies and the vacancies reported to the Commission during the period of currency of the list.

5. **Method of appointment** : Direct Recruitment.
6. **Age limit** : 22-40. Only candidates born between 02.01.1982 and 01.01.2000 (both dates included) are eligible to apply for this post with usual age relaxation to Scheduled Castes, Scheduled Tribes and other Backward Communities. (For other conditions regarding age relaxation please see Para 2 of Part II the General Conditions) of the Gazette Notification.
7. **Qualifications** :
 - 1) Masters Degree with not less than 50% marks under the faculty of Humanities, Science, Commerce or Languages from any statutory University established in India
 - 2 (a) M.Ed Degree with not less than 50% marks with specialization in Vocational Education or Work Experience or Basic Education or Life Skill Education or Environmental Education or Guidance and Counselling from any statutory University established in India
 - OR
 - (b) Any M.Ed Degree with not less than 50% marks from any statutory University established in India with Post Graduate Diploma or Diploma in any of the specialization subjects mentioned in item 2 (a) above from any institution recognized by the Government of Kerala .
 - 3)Teacher Eligibility Test or National or State Eligibility Test or M.Phil or Ph.D in the subject concerned or in Education.

Note:- 1) Candidates who have acquired Non-qualifying degrees viz. Ph.D/M.Phil/Post Doctoral Fellowship will be awarded weightage marks provided that such non-qualifying degrees shall be in the subjects pertaining to the basic qualification stipulated for the post .Weightage marks for non qualifying degrees for ranking will be awarded as detailed below.

Non-Qualifying M.Phil - 2 marks

Non-Qualifying Ph.D- 4 marks

Both M.Phil & Ph.D (Non-Qualifying) -5 marks

Post Doctoral Fellowship - 2 marks

- 2) Non-Qualifying degree means the additional qualifications which are earned apart from the qualifications insisted on as essential qualifications for the post. If Ph.D/M.Phil/Post Doctoral Fellowship is reckoned as necessary qualification for the post,weightage marks will not be awarded for it.

- 3) Weightage marks will be awarded only to those non-qualifying degrees which are claimed in the application and which are acquired on or before the last date for receipt of applications
- 4) Rule 10 a (ii) of part II of KS&SSR is applicable.
- 5) The Degrees / Diplomas awarded by UGC approved Universities or Institutions established through an act passed by Parliament/State Legislative Assembly in accordance with the condition laid down in G.O (M.S) No.526/PD dated 17/07/1965 are acceptable for appointment in Government Services.
- 6) Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of certificate verification. Then only such qualification shall be treated as equivalent to the prescribed qualification.
- 7) In the case of difference in original caste/ community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate/ Community Certificate at the time of certificate verification.

8. Method of submitting applications :-

- (a) Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for the post. The photograph uploaded should be one taken after **31.12.2012. Candidate who have created new Profile from 01.01.2022 should upload their Photograph taken within a period of 6 months.** Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the print out of the application by clicking on the link 'My applications' in their profile. All correspondence with the Commission, regarding the application should be accompanied with the print out of the application.** The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original Documents to prove qualification, experience, age, Community etc. have to be produced as and when called for. The profile correction made by the candidates themselves or through the office of the KPSC on request after the last date fixed for the receipt of applications will not be reflected in the application. Such corrections will come into effect only on the date on which corrections have been made.
- (b) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
- (c) Appropriate disciplinary action as per KPSC Rules of Procedure , Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.
- (d) "Candidates who have AADHAAR Card should add AADHAAR as ID Proof in their profile."
