Note 7. Copy of answer scripts of the OMR Test held on 13.03.2022 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Candidates are invalidated as per the Notification No :ERVII (2) 1823/2022/EW Dated 02.06.2022.
