Note 4: A Physical Measurement and Physical Efficiency Test will be conducted for the candidates included in the Short List. Date, Time and Venue of the Physical measurement and Physical efficiency test will be intimated to the candidates in due course. Detailed instructions will be published in the Ranked List to be published for the post.

Note 5 : Candidates included in the Short List who qualify in the Physical measurement, Physical efficiency test and in the swimming test are required to produce Community Certificate(in Form III/digitally signed Certificate) issued by the competent Revenue Authority not below the rank of Tahasildar as specified in Kerala Gazette in case of SC/ST, Non Creamy Layer Certificate as per G.O(P) No 81/09/SC/ST/DD dated 26.09.2009 issued by the concerned Revenue Authority in case of other reservation communities and those who have claimed for EWS reservation are required to produce EWS Certificate as per G.O(Ms) No 2/2020/P&ARD dated 12.02.2020 at the time of Verification.

Note 6 : According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note 7 : Candidates who wish to obtain a photocopy of their OMR Answer Sheets relating to the examination held on 13.03.2022 will be issued to those candidates who, apply for the same remitting the prescribed fee after the approval of the Ranked List.

Note 8 : Candidates whose Register Numbers are invalidated are advised to refer to the invalidation Notification No. ER VII(2) 1823/2022/EW dated 02/06/2022.
