Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List who qualify in Physical measurement, Physical Efficiency Test and Swimming Test are required to produce Community Certificate (in Form III/ Digitally Signed Certificate) issued by the Competent Revenue Authority not below the rank of Tahsildar as specified in Kerala Gazette in case of SC/ST , Non Creamy Layer Certificate as per G.O (P) No. 81/09/SC/ST/DD dated 26.09.2009 issued by the concerned Revenue Authority in case of other reservation communities and those who have claimed for EWS reservation are required to produce EWS Certificate as per G.O MS.) No. 2/2020/P &ARD dated 12.02.2020 and Medical Certificate in the prescribed form as per Gazette Notification obtained from a medical officer not below the Rank of a Civil Surgeon at the time of Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **13.03.2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER VII(2) 1823/2022/EW dated 02.06.2022.
