Note :- (4) The Short list is prepared based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (5) Candidates included in the Short List who qualify in the Practical Test (Driving Test) should present and produce in person the original documents for One Time Verification. **Date,time and Venue of Practical Test and OTR Verification will be intimated in due course.**

Note :- (6) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short list without further notice.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) SC/ST Candidates included in the Short List are required to produce Community Certificate (in form III/ Digitally Signed Certificate) issued by the Competent Revenue Authority not below the rank of a Tahsildar as specified in Kerala Gazette and candidates belonging to other reservation communities are required to produce a Non Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD dated 26.09.2009 issued by the competent Revenue Authority at the time of Verification.

Note :- (9) Copy of answer scripts of the OMR Test held on **17-08-2021** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ERVII(2) 4827/21/EW Dated 17.12.2021.
