Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes included in this list are required to produce Non-Creamy Layer Certificate as per G.O (P) No. 81/09/SC/ST/DD Dated 26.09.2009 issued by Village Officer along with other documents at the time of OTR verification. SC/ST candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) regulations of issue of Community Certificate Rules 2002 by the Revenue Authority not below the rank of Tahsildar and candidates belonging to the Economically Weaker Section (EWS) included in this list are required to produce certificate issued by the Competent Revenue Authority along with other documents at the time of OTR verification.

Note :- (7) Copy of answer scripts of the OMR Test held on 14-11-2021 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
