Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post later.

Note :- (7) Candidates included in the Short List are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) regulation of issue of Community Certificate rules 2002 by the Revenue authority not below the rank of Tahsildar along with other documents at the time of OTR Verification.
