Note :- (6) Candidates belonging to Other Backward Classes included in the Probability List are required to produce Non Creamy Layer Certificate as per G.O.(P)No. 81/09/SC/ST/DD dated 26/09/2009, SC/ST candidates included in this list are required to produce Community Certificate in Form III or digitally signed issued by Revenue Authorities not below the rank of Tahsildar and Candidates belonging to Economically Weaker Sections should produce relevant certificate as per G.O.(Ms) No.2/2020/P&ARD dated 12/02/2020 in proof of their claim along with other documents mentioned at the time of OTR Verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **26-03-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : .ER VII(1)2315/2022/EW dated 13.07.2022.
