Note :- (6) Candidates belonging to Other Backward Classes included in this Short List are required to produce Non Creamy Layer Certificate as per G.O(P) No. 81/09/SCSTDD dated 26.09.2009 along with the other documents at the time of OTR Verification. SC/ST Candidates included in the Short List are required to produce Community Certificate in form III or digitally signed by the Revenue Authority not below the rank of Tahsildar and EWS candidates are required to produce certificate from competent authority.

Note :- (7) Copy of answer scripts of the OMR Test held on **14-11-2021** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
