- (i) Candidates shall apply online only by One Time Registration to [www.keralapsc.gov.in](http://www.keralapsc.gov.in). [Applications](#) in any other manner will be summarily rejected.
  - (ii) Separate Ranked Lists will be prepared for the above districts in pursuance of this notification. The Ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against aforesaid vacancies and also against the vacancies, if any, reported during the currency of the lists.
  - (iii) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O (MS) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he or she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS) No.4/61/PD dated, 02.01.1961. But as per the GO(P) No 12/96/P&ARD dated 16.3.1996 the condition of 5 years service is not applicable for transfer to Idukki, Wayanad and Kasaragod districts. The concession will be available only for getting transfer to these districts but not for getting transfer out of these districts. And this concession will be granted only once in the career of a Govt Servant. Candidates already in Government service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
  - (iv) Candidates should submit their application for this post to the concerned district, where the vacancy is existing and should note the name of that District against the relevant column of the online application. Applications should not be submitted to more than one district in response to this notification. If applications are submitted contrary to the above direction and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her.
  - (v) In case of change in Caste/Community noted in the SSLC Book, candidates must claim their original Caste/Community in the application and shall produce Community Certificate/Non Creamy Layer Certificate as the case may be issued by the Revenue Authorities and the Gazette Notification publishing the change of Caste/Community at the time of OTR Verification for selection to the above post or as when required by the Commission.

(vi) As per G.O(P)No.19/2020/SJD dated 25/08/2020 4 % of the fresh vacancies reported to the Commission for the above post are reserved for the below mentioned categories.

- a) Blindness and Low Vision
- b) Deaf and hard of Hearing
- c) Locomotor disability including Cerebral Palsy, Leprosy cured, dwarfism, Acid attack victims and muscular dystrophy
- d) Autism, Specific learning disability, Mental illness
- e) Multiple disability from amongst persons under clauses (a) to (d) including Deaf-Blindness.

Differently Abled candidates should possess Physical requirements/ Functionality/ Disability percentage stipulated in the above mentioned Government Order.

**5. Method of appointment** : Direct Recruitment

**6 Age Limit** : 18 – 40. (ie; candidates born between 02.01.1982 and 01.01.2004 (Both dates included) are eligible to apply for this post. Other Backward Communities and SC/ST candidates are eligible for usual age relaxation) [including the relaxation as per Para 2(i) of General Conditions].

**Note:-** For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification except para 2 (i).

**7. Qualifications:**

1 A Graduation in Music conferred or recognized by the Universities in Kerala.

OR

a) A Pass in SSLC Examination conducted by the Commissioner for Government Examinations, Kerala or its equivalent.

AND

b) A Pass in Ganapraveena or Ganabhooshana Examination in Vocal Music or Gana bhooshana Diploma in Violin, Veena conducted by the Commissioner for Government Examinations, Kerala.

OR

Music Senior Certificate issued by the Commissioner for Government Examinations, Kerala

OR

Sangeetha Vidwan title of the Central College of Karnatic Music, Madras.

OR

Ganapraveena/Ganabhooshanam (Mridangam) issued by the Commissioner for

- 2 Must have passed the Kerala Teacher Eligibility Test (K-TET-IV) for this post conducted by the Government of Kerala .

**Exemption:** Candidates who have qualified CTET/NET/SET/M.Phil/Ph.D/M.Ed. in the respective subjects are exempted from acquiring TET (G.O. (P) No. 145/16/G.Edn. Dated 30.08.2016 and G.O. (P)No.206/16/G.Edn. Dated 08.12.2016).

As per Government Circular No.1866829/J3/2017/G.Edn dated 09/03/2018,exemptions are given to those who have passed C-TET Primary stage from K-TET Category I and C-TET Elementary stage from K-TET Category II .Based on the above condition, C-TET will not be considered against K-TET Category III & IV.

**Note:-** (i) M Ed which is prescribed as a substitute qualification for K-TET need not be Subject specific ( GO (P) No. 15/2020/G Edn dated 09.10.2020)

(ii)M.Phil in the concerned subject be the one awarded by any of the Universities in Kerala or recognised as equivalent by any of the Universities in Kerala.

NB:(i) Rule 10(a) (ii) of Part II of the KS&SSR will be applicable for this post.

- (ii) Candidates claiming equivalent qualification should produce relevant Government Orders during verification to prove that the qualification claimed is equivalent to the prescribed qualification for the post.

8 **SPECIAL CONCESSIONS REGARDING APPOINTMENT AND AGE LIMIT**

- (i) Preference will be given as laid down in G.O.(MS) No. 50/70/PD dated 12.02.1970 and G.O. (MS) No. 9/78/G.Edn. Dated 21.01.1978 to the wives of Jawans in the matter of recruitment as Teachers, if they possess the prescribed qualifications. Soldiers in active service and those working in Base Establishment are included under the term `Jawans'. Wives of Jawans should select "Are you entitled to any priority" as yes on the online application and give the details in the space following. Such candidates should obtain proper certificates from the Officer Commanding stating the name, military rank and military address of their husbands and produce the same as and when required by the Commission (G.O (MS) No. 509/64/Edn. Dated 19.09.1964, G.O.(MS) No. 614/65/Edn. Dated 09.11.1965 and G.O (MS) No. 243/66/Edn. Dated 27.05.1966).
- (ii) Laboratory Attenders in the departmental High Schools in the State who have rendered at least 5 years satisfactory service and who possess the prescribed qualification will be exempted from age limit. They should produce proper certificates from the headmaster of the school specifying the date of commencement of their service and the total service put in by them as and when required by the Commission. The candidates who claim exemption on this basis will be considered only against vacancies to be filled up by open competition on the basis of merit alone (G.O (MS) No.315/62/Edn. Dated 14.05.1962)
- (iii) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers (G.O (MS) No. 122/75/G.Edn. Dated 27.05.1975 & G.O(MS)No.50/70/PD Dated 12/02/1970).
- (iv) Teachers of the Government Primary and State Nursery Schools who are graduates and are otherwise qualified will be exempted from upper age limit (G.O.(Ms) No.185/70/Edn. Dated 18.04.1970 and G.O.(Ms) No.466/70/Edn dated 11.11.1970).They should produce certificate from authorities concerned as and when required by the Commission.

**Note:-** The candidates who are eligible for the above preferences or concessions by virtue of any of the reason mentioned in Para 2 of the General Condition should claim the same through the "weightage and preferences" link provided in their One Time Registration Profile and give details in the space provided. The applications of candidates who are eligible for concession in upper age limit and who do not claim the same, are liable to be rejected presuming that they are over aged candidates. Upper age limit after allowing the relaxation as per rule should not exceed 50 years of age (see para 2 of General Conditions).

## 9. Method of submitting Application :

Candidates must register as per “ONE TIME REGISTRATION” with the Official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)' before applying for the post. Candidates who have registered shall apply by logging in to their profile using their user ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be one taken after 31.12.2012. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking of the photograph. The candidates creating new profile should upload the photograph taken within Six months. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the User ID for further communication with the Commission. Application once submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link “My Applications” in their profile. All correspondence with the Commission, regarding the application should be accompanied with the printout of the application.** Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Original Documents to prove qualification, Experience, community, Age, etc., have to be produced as and when called for. **“Candidates who have AADHAAR card should add AADHAAR card as I.D. Proof in their profile”.**

If a Written Test/OMR/Online Examination is conducted as a part of this selection, Candidates shall submit a confirmation for writing the examination through their ' One Time Registration' Profile. Such candidates alone can generate and download the Admission Ticket in the last 15 days till the date of test. The applications of the candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Ticket will be published in the examination calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it. Appropriate disciplinary action as per KPSC Rules of Procedure (1976) Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.
