Note :- (6) Candidates belonging to Other Backward Classes included in the Probability List are required to produce Non- Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD dated 2609.2009 and SC/ST candidates included in this list are required to produce Community Certificate in Form III or digitally signed issued by the Revenue authorities not below the rank of Tahsildar along with other documents mentioned at the time of OTR Verification of original documents.
