Note :- (6) Candidates belonging to Other Backward Classes who are included in the Short List are required to produce Non Creamy Layer Certificate and SC/ST candidates included in the list are required to produce Community Certificate issued by the Revenue authorities and candidates belonging to EWS should produce relevant certificate as per GO(MS) No.2/2020/P&ARD dated 12/02/2020 in proof of their claim along with other documents mentioned at the time of OTR Verification.
