Note :- (6) Candidates belonging to Other Backward Classes included in the Short List are required to produce Non Creamy Layer Certificate as per G.O.(P) No. 81/2009/SCSTDD dated 26.09.2009 and SC/ST candidates are required to produce Community Certificate in Form III or digitally approved by the Revenue Authority not below the rank of Tahsildar at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **26-02-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.

Note :- (8) Answer Scripts of no candidate is invalidated as per Notification No: ER VII(1)1825/2022/EW Dated 22.06.2022.
