Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note:- (8) Candidates belonging to Other Backward Classes included in the Probability List are required to produce Non Creamylayer Certificate as per G.O.(P) No.81/2009/SCSTDD dated.26.09.2009. SC/ST Candidates are required to produce Community Certificate in form III or digitally signed by the Revenue Authority not below the rank of Tahasildar.
