Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates belonging to Other Backward Classes, included in the list are required to produce Non-Creamy Layer Certificate as per G.O (P) No. 81/2009/SC/ST/DD dated 26.09.2009 and SC/ST candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulation of issue of Community Certificates, Rule 2002, issued by the Revenue Authority not below the rank of Tahsildar alongwith other documents at the time of OTR Verification.

Note :- (8) Copy of answer scripts of the OMR Test held on **15-06-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER VII (2) 3841/2022/EW dated 10.11.2022 of The Secretary, KPSC, Thiruvananthapuram.
