Applications must be submitted online through the official website of the Kerala Public Service Commission after One Time Registration. Candidates who have already registered can apply through their profile. **Candidates who have AADHAR card should add AADHAR as ID proof in their profile.**

2 Name of post	: ASSISTANT PROFESSOR IN ANATOMY (Special Recruitment for ST only)
3 Scale of pay	: As per UGC Norms

- 4 No. of Vacancy : 01 (One)
- **Note 1 :** The above Vacancy is now in existence. The Ranked list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published for this post under the same method of appointment. Advice for appointment will be made for the above vacancy and also for the vacancies reported exclusively for Scheduled Tribes during the pendency of the list.
- **Note 2 :** Candidates who are appointed in the post should serve for 4 (four) years during the first 10 (ten) years of their service (including the period of training) anywhere in India or any other foreign country under defence services connected with defence, if required. Differently abled candidates and those who have completed 45 years of age are exempted from the above compulsory military service.
- **5 Method of Appointment** : Direct Recruitment (Special Recruitment for Scheduled Tribes only).
- **Note:-** Applications received from candidates other than Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.
- **6** Age : 21-50, Only Candidates born between 02.01.1972 and 01.01.2001 (both dates included) are eligible to apply for this post. No other age relaxation will be allowed.

7 Qualifications:

- (i) Medical Post Graduate Degree such as MD/MS in Anatomy from a recognized University or DNB in Anatomy
- (ii) Three years Physical Teaching Experience or such other teaching experience as prescribed by the Medical Council of India.
- (iii) Permanent Registration under State Medical Council (Travancore Cochin Medical Council)

Note:- 1 The Post Graduate study period for Medical subjects will be considered as teaching experience for appointment as Assistant Professor provided the candidates have undergone Residency Programme during the period of Post Graduate Course. In the case of candidates who have passed the Post Graduate Course without undergoing residency programme a certificate shall be produced by the candidate from the Principal of the College to the effect that the candidate has got teaching /clinical work experience during the Post Graduate Course period.

- 2 DNB qualifications must be acquired from a Medical College which is recognized by any of the Universities in Kerala.
- 3 Provisional Registration with any Medical Council will not be accepted.
- 4 Rule 10(a)(ii) of part II of KS&SSR is applicable.
- 5 In addition to the qualifications prescribed in this notification, the qualifications declared by the Government by Executive Orders or by Standing Orders as equivalent to the prescribed educational qualification, the qualifications decided by the Commission as equivalent to the qualifications prescribed in the Special Rules and the higher qualifications having the above prescribed qualifications as its basic qualification will also be accepted. The Government Order regarding the equivalent qualification / higher qualification should be produced as and when required by the Commission.
- 6 If the caste of the candidate is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce community certificate issued from the revenue authority concerned and the Gazette Notification to prove the same at the time of certificate verification.

8 Mode of Submitting application:

- (i) Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion of the photograph uploaded. Candidates who create their profile from 01/01/2022 should upload their photograph taken within the period of six months The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking of photographs. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Proir to the final submission of the application on the profile candidates must ensure correctness of the information incorporated in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisionally accepted and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the **application.** The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, Community etc. have to be produced as and when called for.
- (ii) Candidates are directed to submit the applications after reading and understanding the General Conditions incorporated as Part II of the Gazette Notification. Applications which do not conform to the General Conditions are liable to be rejected.

- 12 Appointment are made on the basis of the rank secured in the ranked list of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O.(P) No. 21/76/PD dated, 17.01.1976 and G.O.(P) No.25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(A), 17(B) of Part II of Kerala State and Subordinate Service Rules, 1958.
- 13 If written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The period regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
- 14 As per Rule 22 of KPSC Rules Of Procedure, candidates making false claims about qualifications such as education, experience etc., and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination are liable to be disqualified for being considered for the post they applied for, or debarment from applying to the Commission either permanently or for a specific period, or the invalidation of their answer scripts in the examination or products in the practical test they attend, or the initiation of legal proceedings against them, or removal or dismissal from office or any disciplinary/ legal action against them if they have already been appointed, or any one or more of the above.
