- <u>Note</u>:- (i) Candidates shall apply online only by One Time Registration on <u>www.keralapsc.gov.in</u> Applications submitted in any other manner will be summarily rejected.
 - (ii) In the absence of suitable candidates, the vacancies set apart for By Transfer recruitment shall be filled up by the candidates from the Ranked List prepared for Direct recruitment.
 - (iii) The applicant should be an approved probationer/Full member of the Kerala General Education subordinate service as on the date of application.
 - (iv) Separate Ranked Lists will be prepared for each district in pursuance of this notification. The Ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancies and also against the vacancies, if any, reported during the currency of the list.
 - (v) Candidates should submit the application for this post to any one of the above District and should note the name of the District against the relevant column of the online application. Application should not be sent to more than one district in response to this notification. If applications are sent contrary to the above direction, and if the candidate is selected, his/her name will be removed from the Ranked list and disciplinary action will be taken against him/her.
 - (vi) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms)No.154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS)No.4/61/PD, dated 02.1.1961. Candidates already in Government service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
 - (vii) The rules regarding the reservation of appointment contemplated in Rules 14 to 17 in Part II of the KS & SSR are not applicable to recruitment by transfer.

7. Qualifications:-

(1) A Degree in Malayalam or Graduation with Malayalam as one of the optional subjects under pattern II of Part III and B.Ed/BT/LT conferred or recognized by the Universities in Kerala.

OR

A Title of Oriental Learning in Malayalam awarded by the Universities in Kerala and Certificate in Language Teachers Training issued by the Commissioner for Government Examinations, Kerala.

Note:

The Degrees/Diplomas awarded by UGC approved Universities or Institutions established through an act passed by Parliament/State Legislative Assembly in accordance with the conditions laid down in G.O.(M.S) No.526/PD dated 17.07.1965 are acceptable for appointment in Government Service.

(2) Must have passed the Kerala Teacher Eligibility Test (K-TET) for this post conducted by the Government of Kerala.

Exemption:

- 1. Candidates who have qualified CTET/NET/SET/M.Phil/Ph.D in the respective subjects / M.Ed. in any subject are exempted from acquiring TET (G.O. (P) No. 145/16/G.Edn. Dated 30.08.16, G.O.(P)No.206/16/G.Edn. Dated 08.12.2016 and G.O (P)No.15/2020/G.Edn dated 9.10.20)
- 2. As per the conditions laid down in Government Circular No. 1866829/J3/2017/ G. Edn. Dated 09.03.2018 those who passes CTET primary stage and CTET Elementary stage were excluded from KTET Cat.I & KTET Cat.II respectively. Also CTET qualification can't be considered as an alternative qualification for KTET Cat. III and Cat. IV.

Note:-

- M.Phil in the concerned subject be the one awarded by any of the Universities in Kerala or recognised as equivalent by any of the Universities in Kerala.
- (ii) Post Graduates in Malayalam are also eligible to apply for the post provided they have B.Ed/B.T/L.T qualification.
- (iii) B.Ed should also be in the concerned language viz. Malayalam.
- (iv) The discipline in which B.A/M.A and B.Ed. Degree were obtained should be mentioned in the application form.
- (v) The Employees of the General Education Department who have entered in Service before 31.03.2012 and have completed the prescribed period of Service as Clerk, Typist, Attender, Office Attendant/ Binder are exempted from acquiring KTET qualification (GO (MS) No. 134/2017/G. Edn. Dated 30.10.2017).
- (vi) KS & SSR Part II Rule 10 a (ii) will be applicable for the post.
- (vii) "In addition to the qualifications prescribed in this notification, qualifications declared by the Government as equivalent qualifications through Executive/Standing Orders and higher qualifications with prescribed qualification as basic qualification will be accepted. Government Orders regarding equivalent/higher qualification shall be produced as and when called for by the Commission".
- 3) Service as Clerk/Typist/Attender/Office Attendant/Binder in the General Education Department with not less than 5 years as on the date of application.

Note:

Documents to prove qualification, date of birth and service have to be produced as and when called for. Candidates should obtain a Service Certificate (in original) in the form prescribed below from the Head of Office/Department and produce as and when called for.

9. Mode of Sending applications:-

a) Candidates must register as per "ONE TIME REGISTRATION" with the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be taken after 31.12.2012. Candidates who are creating profile newly from 01.01.2022, should upload the photograph taken within 6 months. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the

online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application. The Application will be summarily rejected if non-compliance with the notification is found in due course of processing.
