 - (ii) The post of Ayah in all the Departments shall be reserved exclusively for women candidates.
 - (iii) Note: Rule 10 (a) (ii) of Part II of KS&SSR is applicable.

 In addition to the qualifications prescribed in the notification, the qualifications recognized by executive orders or standing orders of Government as equivalent to a qualification specified for a post, in the Special Rules or found acceptable by the Commission in cases where acceptance of equivalent qualifications is provided for in the rules and such of those qualifications which pre-suppose the acquisition of the lower qualification prescribed for the post, shall also be sufficient for the post.
