Candidates whose inclusion is due to the benefit of reservation to ensure adequate representation, shall have to prove their claim by producing Community Certificate at the time of One Time Registration Verification. If they are included in the list to be published after the final examinations. If they fail to prove their claim, their application will be summarily rejected.

Note 3. The marks secured in the Common Preliminary Examination 10th level by the candidate will be considered only for ascertaining the eligibility to appear for the final exam and will not be considered for the purpose of final ranking and shall not have any relevance while preparing the Rank List for the post.

Note 4. If any of the documents produced by any candidate is found defective or invalid the Commission reserves the right for rejection of their candidature at any stage of selection.

Note 5. According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply in the prescribed form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy, or downloaded and printed in A 4 size paper from the Commission's website www.keralapsc.gov.in or photocopied along with prescribed fee of Rs. 85/- (Rupees Eighty Five Only) under the Head of Account "0051 - PSC - 105 State PSC 99 -Examination Fee". Such applications should reach the Deputy Secretary (Examinations)-III, Kerala Public Service Commission, Pattom P.O., Thiruvananthapuram - 695004 on or before 07/02/2023 ie, within 15 (Fifteen) days from the date on which this Eligibility List is uploaded in the website of the Commission. Applications submitted in any other manner will not be considered. The candidates can avail only one chance for rechecking after the Approval of Eligibility List within the time limit fixed above. Rechecking of answer scripts invalidated due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded. Candidates who have submitted the application for rechecking of the OMR answer scripts will be informed of their results through profile message only. Such message can be viewed by logging on to their 'One Time Registration' profile using their User ID and Password.

Note 6. Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to the above examination shall remit a Fee of Rs.335/- (Rupees Three Hundred and thirty five only) in any of the Treasuries in the State (Head of Account: 0051 - PSC - 800 - State PSC -99-Other Receipts). The duly filled in application in the prescribed form available from the official website of the Commission www.keralapsc.gov.in along with the original chalan should be submitted to the Deputy Secretary (Examinations)-III, Kerala Public Service Commission, Pattom P.O., Thiruvananthapuram- 695004. Such applications should reach the Deputy Secretary (Examinations)-III, Kerala Public Service Commission, Pattom P.O., Thiruvananthapuram - 695004 on or before 07/02/2023 ie, within 15 (Fifteen). days from the date on which this Eligibility List is uploaded in the website of the Commission. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not of their own, and legal proceedings will be initiated against those who do so.
