Such applications should reach the Deputy Secretary (Examinations)-III, Kerala Public Service Commission, Pattom P.O., Thiruvananthapuram - 695004 on or before 30/01/2023 ie., within 15 (Fifteen) days from the date on which this Eligibility List is uploaded in the website of the Commission. Applications submitted in any other manner will not be considered. The candidates can avail only one chance for rechecking after the Approval of Eligibility List within the time limit fixed above. Rechecking of answer scripts invalidated due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.
