Date,time and Venue of OTR Verification and Practical Test (T-TEST AND ROAD TEST) will be intimated through profile message and SMS.**

Note :- (5) Candidates belonging to Other Backward Classes included in the Short List , who qualify the **Practical Test (T-TEST AND ROAD TEST)**, are required to produce Non- Creamy Layer Certificate issued by Village Officer as per G O (P) No.81/09/SCST DD dated 26/09/2009 and SC/ST candidates are required to produce Community Certificate issued under Rule 4 of Kerala (SC/ST) Regulations of issue of community certificate Rules 2002 by the Revenue authority not below the rank of Tahildar and candidates belonging to Economically Weaker Sections should produce relevant certificate as per G.O.(Ms) No.2/2020/P&ARD dated 12/02/2020 in proof of their claim along with Medical Certificate in the format prescribed in the Notification and other documents at the time of OTR Verification of original documents.

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Copy of answer scripts of the **OMR Test held on 17/08/2021** will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List.
